Sub: Appeal dt. 01.04.2019 under RTI Act -2005.

Sir,

This has reference to your appeal dated 01.04.2019 under RTI Act 2005 received on 08.04.2019. You have preferred appeal against the reply dated 25/26.02.2019 of CPIO stating that the reply given by Sh. Manoj Lal, CPIO is not acceptable to you.

Vide appeal dt. 01.04.2019 the appellant has requested to submit all necessary information sought by him in his RTI application dt. 23.01.2019.

I have carefully examined your RTI application, order of the CPIO, appeal and other relevant record. In the capacity of appellant authority I have considered your quarries and the reply furnished by the CPIO and my query-wise reply is as follows:

- 1. Quarry no-1 of your RTI application dt.23.01.2019 : As informed by the concerned department the details are as follows: FIR No.161 dt. 26.07.2016 lodged with the officer in charge, Bidhan Nagar North Police Station, Salt Lake, Kolkata later on case transferred to CID, West Bengal.
- 2. Quarry no. 2 to 9: No information can be provided in respect of quarries from 2to 9 as the said quarries relates to the investigation and prosecution done by the CB-CID, Kolkata and the matter which is part of criminal investigation and prosecution by the State is in any case exempted from disclosure under section 8(1)(h) of RTI Act, 2005. For such information you may like to approach the competent public authority.

Quarry no. 10 to 15: Information about the disciplinary actions against the employees of NSIC is third party personal information, the disclosure of which is exempted under section 8(1)(j) of the RTI Act. Moreover the information/record of the disciplinary actions against employees of the NSIC has no larger public interest. Hence no information can be furnished in respect of quarries No. 10 to 15 of your application dt. 23.01.2019.

In view of the above observations, your appeal dt. 01.04.2019 against the order of CPIO dated 25/26.03.2019 stands disposed of. However, if you wish to file an appeal before the Central Information Commission, you may file the same within 30 days from the date of receipt of this letter.
