Subject : Complaint regarding issue of false and undeserving NSIC certificate to Howrah based firm called M/s. Shiv Shakti Industries, 545, G.T.Road, Howrah for items like Steel Channels, Rounds and Flats to IS:2062 Gr. 'A' and IS:1875 in exchange of money by certain NSIC officials of Howrah and Kolkata

With reference to the above, it brings me great pain to inform you that certain officers of NSIC in Kolkata and Howrah are selling and not issuing NSIC certificates to undeserving firms even knowing very well that they are not possessing the manufacturing set up for those items.

The price for issuing such certificates starts from as low as Rs 50,000/- to Rs 4,00,000/-. When I met certain officials in Howrah and Kolkata, they advised me to keep mum and rather be a beneficiary of their fraud scheme.

Since, I am a law abiding citizen, I know very well that someday these people will meet the same fate as that of Sharda Scam perpetrators.

Surprising, this certificate shows that the firm manufactures Rounds and Flats to IS:2062 without possessing a Rolling Mill.

Since, this is a fraud activity, you are requested to take immediate departmental action against the corrupt officials and also the firm by black-listing them forever.

I shall be compelled to file a corruption case against your departmental babus, if no action is taken within 30 days.
