Sub: Information under RTI Act.

This has reference to your application bearing Registration No.MMSME/R/2015/60037 dated 09/02/2015 received through Ministry of Micro, Small & Medium Enterprises vide their letter No.A-50/70/2015-SME dated 11th Feb. 2015 (received in NSIC on 16/02/2015). Ministry has transferred the above application to NSIC under Section 6(3) of the RTI Act. We have been requested to provide the requisite information directly to you under intimation to the above Ministry. Following information has been sought by you. Our reply in this regard as provided by the concerned Division of NSIC is as under:-

Information Sought	Our Reply
Kindly inform me that if our NSIC Registration Certificate was expired and want to renew within 30 days from expired date, any late payment charged for the late renewal. Is there any penalty charged, if yes, how much amount of penalty or late payment fees?	In this regards, it is to inform you that the Micro & Small Enterprises registered with NSIC under its' Single Point Registration Scheme will have to apply for renewal of their Enlistment Certificate before its' expiry date. After expiry of Enlistment Certificate, it would be treated as cancelled and the unit has to apply fresh for Enlistment Certificate with NSIC. In case the unit is willing to renew their registration and maintain continuity of the registration number under NSIC's Single Point Registration Scheme, they have to pay the fees equivalent to fresh registration alongwith the stipulated documents.

However, if you are not satisfied with the reply, you may file an appeal before the Appellate Authority of NSIC within 30 days from the date of receipt of this reply. Name & address of the Appellate Authority is given below:-
