Subject: Information required under Right to Information Act 2005.

This has reference to your RTI application dated 14/02/2015 (Recd. in NSIC on 20/02/2015) enclosing therewith a copy of your complaint dated 21/01/2015 addressed to Chief General Manager, Vigilance, NSIC Ltd., New Delhi and a copy of the same was also endorsed to Chief General Manager, NSIC Limited, 20-B, 7th Floor, Abdul Hamid Street, Kolkata-700069(West Bengal).

It has been stated in your above complaint to Vigilance Division that certain officers of NSIC in Kolkata and Howrah are selling NSIC certificates to undeserving firms and requested to take immediate departmental action against such officials.

Vide your above cited RTI application dated 14/02/2015 you have sought copy of File Noting of Delhi Office as well as Kolkata Office regarding the complaint lodged by you.

In this connection, it is to inform you that after receiving your above complaint, as per the rules, NSIC Vigilance Division had issued **you a letter dated 10/02/2015 wherein you were advised to confirm within 15 days from the date of receipt of their letter that the said complaint was made by you and also to send some more information, if any available with you in connection with the said complaint so that they may look into the matter.** But, no reply was received by them from you till 3rd March, 2015. Thereafter, NSIC Vigilance Division vide its **another letter dated 03/03/2015** again made a similar request and once again requested you to confirm about your complaint within next 15 days from the date of receipt of their above letter. It was also stated in their letter that this may kindly be treated as URGENT. Even after their repeated requests, NSIC Vigilance Division has not so far received any response from you regarding the same. Instead of giving any reply of NSIC's Vigilance Division letters dated 10/02/2015 & 03/03/2015 respectively as mentioned above, you have now filed an RTI application and seeking the said information under RTI Act. It is to inform you that in the absence of required confirmation/details from you (the complainant), no further action was taken by Vigilance Division of NSIC.
