COMMERCIAL AND GENERAL TERMS & CONDITIONS

1. Tenderers shall submit their offers in a sealed cover superscribed as “**Tender for Obsolete Machines, E-Waste and M.S.Scrap**” at NTSC Chennai on or before **05.02.2018** up to **2 P.M.** The tender should be submitted in two bid system – **Technical Bid** and **Price Bid**. In **Technical Bid cover** you have to submit your profile, copy of pan card, service tax registration, GST registration, ESI registration, EPF registration, Ownership registration etc., and other documents if any. The application fee and EMD should be submitted in this cover. In **Price Bid cover**, only the Price Bid as per Annexure should be submitted.
2. The machines/ E-Waste/M.S.Scrap as detailed in the Notice Inviting Tender are offered for sale on “AS IS WHERE IS” basis without any guarantee to the condition of any item to be sold. The purchaser shall not be entitled to raise any objection on the ground that the general description of the items does not tally with the items for which delivery is affected. The description of the Obsolete machines, E-waste and M.S.Scrap is believed to be correct and sold with the assumption that the purchaser had inspected it and fully aware about the conditions of the items. The purchaser is not entitled to raise any objection at a later date regarding the description, condition, quality etc. of the items or for non –delivery of any item.
3. Tenderers are strictly advised to quote their rates separately for individual machines/E-waste/ M.S.Scrap. Offers quoted should be specific. Otherwise, it would be liable for rejection.
4. The Tender should be accompanied with Tender Application fee and Earnest Money of Rs. 5,000/- (for **each machine / E.Waste/ M.S.Scrap**) in the form of a Demand Draft/Pay Order in favour of “**NSIC Ltd.**” payable at Chennai. **No Cheque or cash shall be accepted.
