INSTRUCTION AND GENERAL TERMS & CONDITIONS TO THE TENDERERS

The Tender shall be submitted in accordance with the Instructions and General Terms & Conditions (here after called as instructions). Any tender not confirming to the instructions as explained under is liable to be rejected. These instructions shall form the part of the tender:

1. The tender should be submitted in **sealed cover** super scribed as **"Sale of Old I.C. Diesel Engines"**.
2. In case Tender Document is downloaded from the web site, the cost of Tender Document i.e. Rs. 500/- (Rupees Five Hundred Only) should be enclosed with the Tender by way of Demand Draft/Pay Order in favour of **"NSIC Ltd"** payable at **Rajkot**. However, tenderers registered with National Small Industries Corporation under Single Point Registration Scheme shall be exempted from deposit of cost of Tender Document.
3. The Tender shall be submitted along with the Demand Draft/Pay Order for Rs. 10,000/- towards Earnest Money Deposit in favour of **"NSIC Ltd"** payable at **Rajkot**.

The units registered with Central Purchase Organization (DGS&D), National Small Industries Corporation (NSIC) or the concerned Ministry or Department shall be exempted from the payment of Earnest Money as defined under Rule 157 of General Financial Rules (GFR), 2005.

In such case, valid copy of the certificate showing registration with the above mentioned institutions to be enclosed along with the bid.

4. Refund of EMD to unsuccessful bidder will be made within 10 working days from awarding of letter. No interest will be paid.
5. The tender shall be completed in all respect and should be signed with date by the Authorized Signatory of tenderer on all the pages.
6. The tenderer has to submit documentary proof of the business location like- Ownership Proof, Statutory registrations, Memorandum & Articles of Association, Registration Deeds etc.

7. The offer price shall be quoted for the Old I.C. Diesel Engines on whole lot basis, excluding government taxes and duties as applicable. The Old I.C. Diesel Engines mentioned in Annexure-B is to be sold on "**as is where is basis**" as photographed. The photographs of the Old I.C. Diesel Engines are enclosed herewith for your ready reference. However, the Tenderers are free to inspect the aforesaid at the NSIC Technical Services Centre, Aji Industrial Area, and Bhavnagar Road, Rajkot- 360003 from 10.30 am to 4.00 pm on any working day from Monday to Friday w.e.f. 15.03.2018. Accordingly, the delivery of whole lot would be issued to the selected bidder.

8. Procedure for Lifting of Old I.C. Diesel Engines:
 - a. **The successful Tenderer** shall deposit amount for a whole lot of Old I.C. Diesel Engines as under by way of one Demand Draft/Pay Order in favor of 'NSIC Ltd'. Towards the cost of whole Lot of Old I.C. Diesel Engines within 03 (three) working days from the date of awarding the order.
 - b. The truck/tempo for Old I.C. Diesel Engines lifting and carrying shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of Old I.C. Diesel Engines into truck/ tempo at their own cost and NTSC will not pay any charges towards loading / octorai/ any other duty for the same.
 - c. No truck/tempo shall be allowed to leave NTSC premises without issuance of Gate Pass.
 - d. After award of order to lift the Old I.C. Diesel Engines from NTSC premises if the Old I.C. Diesel Engines is not lifted within 07working days, the successful bidder shall not be allowed any extra time to lift the Old I.C. Diesel Engines any deposited amount with NTSC shall be forfeited.

9. All responsibility related to labor, P.F., ESI, Insurance etc. or any taxes as applicable will be of the successful Tenderers. NTSC shall not be responsible for the same.

No objection shall be raised on the ground that the arbitrator so appointed is an employee of NSIC or is one of the parties to the tender himself or that the persons so appointed had to deal with the matter to which the tender relates in his official capacity.
