1. General Conditions:-

- 1.2 The details of installed system are available in Bill of Quantities.
- 1.3 The service provider shall provide direct service and cannot sub-let the work.
- 1.4 The Agencies can inspect the site and equipments with the Technician 10am to 5 pm on all working days. No claim entertained for non awareness of the site/equipments conditions and constraints.
- 1.5 Sealed offers are invited for the Annual Maintenance contract of Fire Fighting & Fire Alarm system as per the bill of quantity enclosed at annexure-A.
- 1.6 Corrections, if any in the tender must be attested by the tenderer.
- 1.7 NSIC reserves the right to reject all or any tender wholly or partly without assigning any reason whatsoever.
- 1.8 Late tenders will not be considered and shall be rejected.
- 1.9 Water & Electricity shall be provided at one point free of cost.
- 1.10 The rates quoted should be on FIRM & FIXED basis.

2. Earnest Money Deposit (EMD)

- 2.1 The tender should be accompanied with an earnest money deposit of Rs.5,000 /- in the form of demand draft in favour of "The National Small Industries Corporation Ltd", payable at Bhubaneswar. No Cheques will be accepted.
- 2.2 Tenders received without prescribed earnest money shall not be considered.

3. Eligibility conditions

- 3.5 Self attested copy of documentary proof as required above must be furnished along with technical bid Part-I and in case the required information and documents with the technical bid are not furnished, the tender shall be rejected.

- 4. The Technical Bid (Envelope-I) should not contain any financial information related to rates of items etc. In selecting technically suitable parties, the decision of NSIC will be final and binding. - 10. Nothing extra shall be paid on account of any discrepancy in nomenclature of items. The bidders/Tenderer shall seek clarifications if any before submitting the tender.
- 11. While submitting the tender, any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender are liable to be rejected.

The financial bids of the participants which are found to meet all the requirements as specified in the Technical Bid will only be opened on a date which will be communicated at the appropriate time. Only the authorized representative of the firms will be present during the opening of technical and financial bids.

GENERAL CONDITIONS OF CONTRACT

- Corporation shall mean 'The National Small Industries Corporation Ltd.
 (A Government of India Enterprise) "NSIC-IMDC Building Plot No-6,

 shall include their legal representatives, successors and permitted
 assigns.
- 2. The bids should be valid in the case of all the tenders for at least 04 months from the date of opening of the tender. In the case of the successful tenderer, rates quoted shall be valid for the entire period of the contract.
- 3. The contractor or his representative should not remove, disturb, and dislocate the existing equipment and its parts from its positions until and unless it is authorized by the Engineer–in Charge.
- 4. The entire installation should be intact at any time of inspection as was handed over to him at the time of initial taking over of its maintenance and operation. Care shall also be taken not to damage installation due to improper handling.
- 5. The Contractor shall inspect and examine the Site and its surrounding and shall satisfy himself before submitting his tender as to the nature of the Site, the quantities and nature of works and material necessary for the providing the services.
- 6. The Contractor shall be deemed to have satisfied himself before submission of tender as to the Correctness and sufficiency of his tender for the works and of the rates and prices quoted in the Schedule of Quantities, which rates and prices shall except as otherwise provided, cover all his obligations under the contract and all matters and things necessary for the proper completion and maintenance of the Works.

7. TAKING OVER OF FIRE FIGHTING AND FIRE ALARM SYSTEM FOR AMC CONTRACT

All the equipments of Fire Fighting and Fire Alarm system shall be taken from the department on "as and where installed". After completion of the contract, contractor shall hand over the system in perfect running condition (complete in all respects as per inventory) to the department.

8. Commencement of Work

The Contractor is required to start the work within 10 days from the date of award / date of communication of acceptance of the tender. In case it is found that the work has not been taken up within ten days from the date of acceptance of the tender or issue of the work order, the NSIC may cancel the work order and forfeit the Security Deposit, deposited along with tender without any further information to the Contractor.

9. DURATION OF CONTRACT

The contract would be initially for a period of 01 years from the date of commencement of work. However, the rates shall be quoted for 01 year in Bill of quantities. It can be extended further period of one year on the same terms and conditions, if both parties are desire/agreed. In case the party will not rendered services satisfactorily in the contract period, the contract will be terminated by NSIC by given 10 days notice.

10. Renewal of the contract

After expiry of the AMC of 01 years, the agency/contractor may be required to provide AMC services for subsequent year also which can be extended further on satisfactory performance of the previous year of the contract.

- 11. The rates of AMC shall be inclusive of all taxes, duties octroi, works contract tax, cartage loading, sales tax, turnover tax and any other statutory taxes and service tax complete in all respects, valid for a period of one year from the date of award of contract.
- 12. The tenderer shall take into account basic price, cost of labour, T&P, taxes as applicable, conveyance / cartage etc. before quoting the rates. No extra claim what so ever in this regard shall be entertained. Parties are required to submit there PAN No., Tin No, Service Tax no, GST registration.
- 13. The tenderer shall quote the rates in the enclosed "BOQ of the equipments of Fire Fighting and Fire Alarm system in annexure "A" only. The AMC is Non Comprehensive type. Any material /Equipment required for smooth functioning of the system will be provided by NSIC.

14. PAYMENT TERMS AND CONDITIONS:

- The payment to the agency will be made on quarterly basis at the end
 of each quarter against invoice with PAN number, raised by the
 agency and based on past performance. TDS, Service Tax, WCT and
 any other tax as applicable as per prevailing rates will be deducted
 before making the payment. Quarter shall mean three months.
- The maintenance charges quoted by the agency per item is on yearly basis inclusive of all taxes and levies applicable. No escalation of prices shall be permitted on any ground.
- The certified AMC amount will be released on quarterly basis (i.e. four equal quarter) at the end of each quarter on production of bill and service reports duly signed by the Engineer in charge or any other authorized staff of the NSIC Ltd. IMDC Building, Bhubaneswar.
- This is the sole responsibility of the contractor to submit the service reports of scheduled / breakdown service report at the time of submission of bill.

15. Security Deposit:

Total security deposit shall be 10 % of the accepted tender cost and shall be deposited by the contractor within ten (10) days of receipt of the letter of intent/notification of acceptance of the tender by him. The earnest money deposited shall be converted into initial security deposit.

All compensation or other sums of money payable by the contractor under the terms of this Contract or any other Contract or any other account whatsoever may be deducted from the security deposit.

Refund *of Security deposit*: Security deposit refundable without interest to the Contractor shall be refunded to the Contractor on the Engineer-In-Charge certifying in writing that the AMC period of 12 months has been completed satisfactorily.

Security Deposit will be forfeited in the event of the contract offered in full or in part not being fulfilled by the Tenderer/Contractor.

The Contractor shall employ its labour in sufficient numbers to maintain the required rate of progress and of quality to ensure workmanship of the degree specified in the Contract and to the satisfaction of the Engineer-in-Charge. The Contractor shall not employ in connection with the Works any person who has not completed eighteen years of age.

- b.) All the workers or employees deployed by the contractors shall be considered the employees of contractor and corporation shall not have any liability what so ever in nature in regard to such workers/employees.
- c.) The Contractor shall pay to labour employed by him directly wages not less than fair wages as per Minimum Wages Act. Fair Wage' means wages, which shall include wages for weekly day of rest and other allowances whether for time or piece work, after taking into consideration prevailing market rates for similar employment in the neighborhood but shall not be less than the minimum rates of wages fixed under the payment of Minimum Wages Act.
- d.) The Contractor shall in respect of labour employed by him or his sub-contractor comply with or cause to be complied with the Contractor Labour Regulation in regard to all matters provided therein.
- e.) The Contractor shall comply with the provisions of the payment of Wages Act, 1936, Minimum Wages Act, 1948, Employers' Liability Act, 1938. Workmen's Compensation Act, 1923, Industrial Disputes Act, 1947, Maternity Benefit Act, 1970 or any modification thereof or any other law relating thereto and rules made there under from time to time.
- f) The Contractor shall indemnify and keep indemnified the NSIC against:
- i) Any claim arising out of third party loss/ damage to life or property caused by/ during execution of the work.
- ii) Any claim arising out of loss/ damage to the workmen engaged by the contractor during execution of the work.
- iii) Any claim due to non-compliance of applicable PF/ Labour laws, ESI regulations etc.

Contractor shall submit an indemnity bond of requisite value indemnifying NSIC as stated above.

17. Income Tax/WCT/TAX

Income tax including surcharge if any, at the prevailing rate shall

be deducted from the Contractor's bills as per the provision of Income Tax Act. The Contractor shall ascertain from the concerned Commercial tax department regarding the applicability of Works Contract Tax / GST/TIN. Necessary deductions will be made from the contractor's bill as applicable.

18. REVIEW OF CONTRACT:

The performance of the firm shall be reviewed in every quarter and if the performance is not found satisfactorily, the contract will be terminated by giving on 15 days notice.

19. Tool and Plants:

The required tools and plants for carrying out the work shall have to be arranged by the Contractor at his cost and no tools will be arranged by NSIC. The Contractor shall keep all required tools at site.

- 20. All the liabilities regarding EPF or ESI of the labours/workmen engaged at the work, wherever applicable as per the prevailing Central or State government norms, shall be borne by the contractor. Corporation shall not be responsible for any liability/claims whatsoever in this regard. Further as and when demanded by the Corporation, the contractor shall submit the proof of deductions/ deposits of such liabilities of their labors/ workmen engaged in the work to the Corporation. In case of default, the Corporation may deduct the payments against these liabilities from the bills of the contractor or may stop the payment of the bill till such time until the compliance is proved by the contractor.
- **21. MOBILISATION ADVANCE:** No mobilization advance whatsoever shall be paid for carrying out this work.
- 22. ARBITRATION AND LAWS In the event of any dispute, the same shall be referred to the sole arbitration of Chairman-Cum-Managing Director, New Delhi of the Corporation or such officer he may appoint to be the arbitrator. There would be no objection that the Arbitrator is an employee of the Corporation or that he had to deal with the matter to which this tender relates is that in the course of his duties as an employee of the Corporation, he has expressed his views or all or any of the matters in dispute or differences. The award of the officer so

- appointed by him shall be final and binding on the tenderers. The venue of Arbitration is at Odisha only. The award of the arbitrator shall be final, conclusive and binding on all parties to this contract. The cost of arbitration shall be borne by the parties to the dispute, as may be decided by the arbitrator(s).
- 23. The contractor shall comply all the norms in respect of deployment of Manpower, safety measures as per the approval given by Govt. of Odisha, Office of the DIRECTOR GENERAL FIRE SERVICES, HOME GUARDS & CIVIL DEFENCE, ODISHA to NSIC in their fire approval of the building.
