### Amendment No. 1 to Tender document No. NSIC/C&P/LOGO DISPLAY/2019

1. Any additional support (of Mild steel angle iron or hollow section) required in existing structure (bottom or back) for Rooftop Logo Display Board and Road side display board is in Tenderer' scope and its price is deemed to be included in offered price. TENDER BOX IS KEPT IN NSIC HEAD-OFFICE C&P CELL.
2. No interest shall be paid on the performance guarantee (security deposit) amount by NSIC for one year period.
3. Two Purchase Order copy (with unit price hidden) in last two years of similar work is required to be submitted in Technical portion or else the Tender shall be taken as non-responsive and shall be summarily rejected. If all the technical details and data required are not found submitted in the technical portion, the Tender shall be taken as non-responsive and shall be summarily rejected by NSIC.
4. Authorization letter is required for the authorized representative for attending the Tender opening on specified date & time. Financial Tender shall be opened in presence of technically qualified Tenderers which shall be intimated to each one of them separately.
5. Tenderers to note that, color GRADIENT is present in new NSIC Logo.
6. Anything not explicitly written but required for technically completing the scope of work is required to be provided by Tenderer and its price is deemed to be included in the offered price.
7. The size of Road side Display Board is revised to 20feet x 8 feet (from 20feet x 4.4feet) (Item no. 2 on page-14 of 23) and so Tenderers to quote keeping this change in mind.
8. The computer developed design of all boards shall be shown and approval taken from NSIC CC-Division for starting the work by successful Tenderer.
9. In tender, Engineer-In-Charge is written as GM (CC) or his authorised representative, same may please be read as GM-SG (CC) or his authorised representative.
10. All Tenderers are hereby informed that TENDER SUBMISSION DATE IS EXTENDED UPTO 12-12-19 15:00HRS AND OPEN SAME DAY AT 15:30HRS.
