Submission of the duly signed tender implies that these conditions of tender have been read by the Tenderer and is aware of the scope of the supply to be supplied. The final acceptance of the tender rests with the Centre Head of NSIC-Technical Services Centre, who reserves the right to accept or reject any or all tenders without assigning any reason therefore.

The Tender shall be submitted in accordance with these terms, as under.

- 1. **Abbreviations/ words used** throughout this tender document are explained below:
  - a) "NTSC" means NSIC-Technical Services Centre
  - b) "NSIC" means The National Small Industries Corporation Ltd.
  - c) "Day" means Calendar day
  - d) "Working day" means Monday to Friday in a week
  - e) "Tender" means tender number NTSCOK/Soft.Trg./Soft Pur./032/15-16
  - f) "Software" means the Licensed Software of Adobe Creative Cloud for team-All App as detailed at Annexure-A.
  - g) If context so requires, "Singular" means "Plural" and vice versa.
  - h) "EMD" means Earnest Money Deposit.
  - i) "Purchaser" means NSIC Technical Services Centre, NSIC Ltd., (A Govt. of India Enterprise).
  - j) "Bid" means the tender document and financial details submitted by bidder.
  - k) "Bidder" or "Tenderer" means the eligible and qualified Original Software Development Company Adobe / Authorized Reseller of Adobe.
  - I) "OEM" means Original Software Development Company i.e. Adobe.

#### 2. Scope of Supplies :

- a) The paper licenses of Adobe Creative Cloud for Teams All App software shall be supplied in compliance to the specifications and quantity mentioned in Annexure- A of the tender.
- b) After the supply of licenses as mentioned in the Annexure A, the bidder has to execute its installation & testing at the designated site in the location. No extra cost shall be paid for this reason.



#### 3. Validity of License :

The software license to be supplied shall remain valid for one year from the date of delivery. The document in its support shall clearly specify the software details along with validity dates for subscription of licenses.

#### 4. Location of supplies:

#### 5. Eligible Bidder:

- a) The Bidder shall be OEM or Authorized Reseller of Adobe having authorization to supply the product. A copy of Authorization letter issued by OEM to Authorized Resellers for participating in tender for the sale of Adobe software licenses for educational purpose and providing support on behalf of OEM shall be enclosed with the Technical bid.
- b) The Bidder shall not be a defaulter to any Govt. organization/ PSU since last 2 years for any reason due to non-supply of software licenses and support even after agreed to supply in stipulated time. An undertaking stating the same should be furnished by the bidder on the company letter head as per format enclosed at Annexure "C".

#### 6. **Tender documents :**

At any time prior to the deadline for submission of bids, the Purchaser may amend the Bidding Documents by issuing addendum. The prospective bidders are advised to remain in touch with the Website for any update in respect of this tender.

### 7. Authorization for submission of tender:

- a) The original and all copies of the bid shall be signed by a person duly authorized to sign on behalf of the Bidder. The written confirmation of authorization (in form of letter on the bidder's letter head) to sign on behalf of the bidder confirming the signature as a person duly authorized to sign should be attached with the technical bid of the tender.
- b) The person signing the tender form or any other documents on behalf of the Bidder shall be deemed to warrant that he has authority to bind the Bidder. If subsequently comes to light that the person so signed had no authority to do so, the purchaser may without prejudice to any other civil & criminal remedies cancel the tender and hold the Bidder liable for all costs, charges and damages.

#### 8. Earnest Money Deposit:

- a) The EMD of Rs. 15,000/-(Fifteen Thousand Only) shall be submitted by way DD(Demand Draft)/RTGS/NEFT/Net banking only for the software licenses quoted by the Bidder. DD or a document in support of transaction made shall be enclosed in the first envelope super-scribed as "Technical Bid". No cash towards EMD shall be accepted. The offers without EMD from the Bidders shall be rejected.
- b) The EMD & Tender Document Fee shall be submitted by way of DD/RTGS/NEFT /Net banking only for which the bank details of purchaser, are as under:

Point Registration Scheme of NSIC and all micro and small enterprises registered with Director of Industries from DIC for the licenses for which this tender issued. To support this, the self-certified scan copy of such valid registration/ exemption certificate is to be attached with technical bid.

- d) The Purchaser shall not be liable for payment of any interest on EMD.
- e) Any request by the bidders to consider their EMD already furnished by them to any of the other office of the purchaser, for any other contract/ tender will not be considered as EMD for this tender.
- f) The EMD will be returned to the unsuccessful bidders soon after the orders are placed on the successful bidder. In case of successful bidder, the EMD will be retailed as a security money by NSIC for the period of twelve months from the date of submission of bill/ invoice for payments.
- g) If any Bidder withdraws his tender before the period of 60 days from the date opening of technical bid or makes any modifications in the terms and the conditions of the tender which are not acceptable to the purchaser, then the purchaser shall, without prejudice to any other rights or remedy, be at liberty to forfeit the EMD.
- h) The EMD will also be forfeited in following cases:
  - i. If the bidder fails to accept the order based on his offer (bid) and within the prescribed time.
  - ii. If the bidder fails to supply the licenses with specifications as mentioned in Annexure -A
  - iii. If the bidder delays supplies beyond a reasonable time resulting in disruption of project.
  - iv. Bidder for any reason whatever, withdraws the tender after it is accepted or become unable or fails to execute the orders within stipulated delivery period
  - v. Submission of misleading/contradictory/false statement or information and fabricated/invalid documents is detected before or after the issue of order to execute the supplies.

#### 9. Special Provision for Micro & Small Enterprises:

Micro and Small Enterprises (MSEs) participating in the tender will be given benefit as per Public Procurement Policy, 2012. Further, the MSEs owned by SC/ST entrepreneurs will also be given benefits as per Public Procurement Policy, 2012.

The Definition of MSEs owned by SC/ST is as given under:

(a) In case of proprietary MSE. Proprietor shall be SC/ST.



- (b) In case of partnership MSE, the SC/ST partners shall be holding at least 51% shares in the unit.
- (c) In case of Private Limited Companies, at least 51% share shall be held by SC/ST promoters.

#### 10. Submission of Tender:

- a) The bidder to examine all instructions, forms, terms and specifications in the tender documents and to furnish with its bid all documents or information as required by bidding document.
- b) The language for all the correspondence and documents related to the tender shall be in English/ Hindi only.
- c) Tender shall be duly filled in. All pages of the tender should be **signed by the Authorized Signatory of Tenderer with company seal.**
- d) Any cutting/over writing etc. in the tender must be signed by the person who is signing the tender. The rates and units shall not be overwritten.
  The financial figures in commercial bid shall always be both in figures and words. In case of any discrepancy in figures and words, the amount written in words shall be considered.
- e) The Tenderer shall submit the copy of PAN & GST registration along with the Technical Bid of the tender document

- f) If both or either of the envelope are not sealed and marked as required, the Purchaser will assume no responsibility for the misplacement or premature opening of the bid.
- g) Tenders received in open covers/ letters/ fax/ email will not be considered.



#### 11. Financial Bid Submission:

- a) The price quoted in financial bid shall be firm and shall include all applicable taxes.
- b) No extra payment shall be paid on account of any discrepancy in nomenclature of items. The Bidder shall seek clarifications if any before submitting the tender.
- c) No representation for the enhancement of the prices of the accepted tender or alteration of the terms and conditions will be entertained till supplies are completed to the designated location.

#### 12. Last date of submission of Tender:

- a) The tender should reach the office of the Centre Head, NSIC-Technical Services Centre, Okhla, Phase-3,New Delhi by 15th, March 2019 up to 15.00 hours.
- b) The purchaser may, at its discretion, extend the deadline for the submission of bids by amending the Tender Documents, in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended. The prospective bidders are advised to remain in touch with website for any update in respect of their tender.
- c) Any bid received by the Purchaser after the deadline for submission of bids shall be declared late, rejected and returned unopened to the Bidder.

#### 13. **Opening of Technical Bid:**

The technical bid of tenders will be opened at NTSC-Okhla on 15th, March 2019 at 16.00 Hours. The Bidder or their authorized representative (One person only) may be present at the time of opening of the tender.

#### 14. Opening of Commercial bid

The Commercial Bid of only technically qualified bidders will be opened on the stipulated due date. The date & time for opening of Commercial Bid shall be intimated to the technically qualified bidders through email, after the evaluation of Technical Bid.

#### 15. Validity of tender:

- a) The tender shall be valid for a period of 60 days from the date of opening of the Technical Bid of tender. Terms and financial details submitted in the bid shall be treated as firm during the said period of 60 days.
- b) In exceptional circumstances, prior to the expiry of the bid validity period, the Purchaser may request bidders to extend the period of validity of their bids. The request and the responses shall be made in writing.



#### 16. Evaluation of Bids:

- a) If there is a discrepancy between the unit price and the line item total that is obtained by multiplying the unit price by the quantity, the unit price shall prevail and the line item total shall be corrected, unless in the opinion of the Purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the line item total as quoted shall govern and the unit price shall be corrected.
- b) If there is an error in a total corresponding to the addition or subtraction of sub totals, the subtotals shall prevail and the total shall be corrected; and
- c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.
- d) To assist in the examination, evaluation, comparison of the bids and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for a clarification of its Bid. Any clarification submitted by a Bidder in respect to its Bid and that is not in response to a request by the Purchaser shall not be considered. The Purchaser's request for clarification and the response shall be in writing only.
- e) If a Bidder does not provide clarifications of its bid by the date and time set in the Purchaser's request for clarification, its bid may be rejected.
- f) The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to supply order, without thereby incurring any liability to Bidders. In case of annulment, all bids submitted and specifically Bid document, EMD deposits shall be promptly returned to the Bidders.
- g) The competitiveness of the bid shall be made at NTSC-Okhla.
- h) NTSC-Okhla shall compare the evaluated prices of all substantially responsive bids to determine the lowest evaluated bid. The comparison shall be on the basis of landed cost at NTSC-Okhla.
- i) At the time the order is awarded, the Purchaser may alter the Quantity of licenses without any change in the unit prices or other terms & conditions of the bid and the Bidding Documents subject to the acceptance of bidder in writing for the same.
- j) The purchaser have right to verify the particulars furnished by the bidder independently.



#### 17. Notification of award:

Prior to the expiry of the period of bid validity, the purchaser shall notify the successful Bidder, in writing, that its Bid has been accepted. The notification letter shall specify the sum that the Purchaser will pay to the bidder in consideration of the supply of Adobe Creative Cloud licenses with the details of location.

#### 18. Delivery Period :

The delivery period for the supplies to be completed within **<u>20 days</u>** from the date of issue of confirmed supply order from NSIC. In case tenderer fails to supply within the accepted period or if the software supplied are found to be different than those specified in Annexure-A of this tender, Centre Head of NSIC-Technical Services Centre, reserves the right to cancel the award letter and may initiate action to debar the supplier for all future business dealing with NSIC for next three years.

#### 19. Services & Support:

The Supplier shall provide services& support on demand towards the installation, registration, activation, maintenance for smooth functioning of the software and upgradations if any, during one year license period with no extra charges and to the satisfaction of the nominated Officer in NTSC, Okhla. The service shall be initiated within two working days of request and shall be fully resolved maximum within 7 days failing which NSIC Technical Services Centre may initiate action to debar Supplier for all future business dealing with NSIC for next three years.

#### 20. Payment

- a) 95% payment will be made against successful installation within 10 days of delivery for which the tenderer shall submit tax invoice in duplicate (original + copy) giving the reference number of the supply order along with delivery note. Balance 5% will be released after 30 days from the date of successful installation subject to satisfactory performance of all the software.
- b) All statutory deductions as applicable like TDS shall be made from the due payment to the Supplier upon submitting the tax invoice.
- c) The rates quoted in the Commercial Bid shall be firm & all inclusive for delivery & installation at destination NSIC Technical Services Centre, Okhla, New Delhi. No extra payment shall be paid on account of any discrepancy in nomenclature of items. The bidder shall seek clarifications if any before submitting the bid. The Corporation will not issue Forms C and/ or D



d) No representation for the enhancement of the prices of the accepted tender or alteration of the terms and conditions will be entertained at any stage.

#### 21. Causes of rejection of tender:

- a) While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected.
- b) If any Bidder stipulates any condition of his own, such conditional tender is liable to be rejected.

#### 22. Claims:

If the licenses supplied are found to be different than those in the accepted offer and are of specifications lower than those stipulated in the accepted offer, the purchaser shall have right to totally reject the supplied software and/or to claim for compensation from bidder. The bidder shall reimburse to purchaser, the claim lodged in writing within 15 (fifteen) days of its demand. The bidder shall also compensate for losses, if any, sustained by purchaser due to wrong license delivery

#### 23. Address for communication:

All the communication with respect to the tender shall be addressed to:

The Centre Head, NSIC- Technical Services Centre, Okhla, Phase-III, New Delhi-110020.

#### 24. Force Majeure:

In the event of any unforeseen circumstances directly interfering with the supply of goods/work/service arising during the execution of order such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, earthquakes, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Bidder shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Either party shall have the option to terminate the contract on expiry of 60 days of commencement of such force majeure by giving 14 days "notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other.

#### 25. Code of Ethics:

The Purchaser as well as the Bidder shall observe the highest standard of ethics including laws against fraud and corruption in force in India namely "Prevention of Corruption Act 1988", during the procurement or execution of such orders. If the bidders are found in Bid pooling or against law against fraud and corruption then their firms may be blacklisted.



#### 26. Jurisdiction:

In the event of any dispute the legal matter shall be subjected to the jurisdiction of Delhi Court only.
