TERMS & CONDITIONS OF THE OFFER

1. <u>Definitions:-</u>

- i. "Corporation" shall mean the National Small Industries Corporation Ltd. (A Govt. of India Enterprise) Okhla Industrial Estate, New Delhi . 110020, and shall include their legal representatives, successors and permitted assignees.
- ii. "Competent Authority" means Chairman cum Managing Director of Corporation and his successors.
- iii. "Officer In Charge " shall mean the officer of the Corporation, not below the level of Deputy Manager, designated by "Competent Authority." as the case may be, who shall supervise and be in-charge of such works.

- ii. In case, the Arbitrator so appointed dies, neglect or refuses to act as an arbitrator or is otherwise unable to act for any reason

whatsoever, it shall be lawful for the Chairman-cum- Managing Director of NSIC to appoint another Arbitrator in place of such Arbitrator in the manner as aforesaid, who shall be entitled to proceed with the reference from the stage where the earlier arbitrator left the proceeding.

iii. The venue of the Arbitration shall be at New Delhi and shall be governed by provisions of the Arbitration & Conciliation Act 1996 as amended by the Arbitration & Conciliation (Amendment) Act 2015 and amended from time to time.
