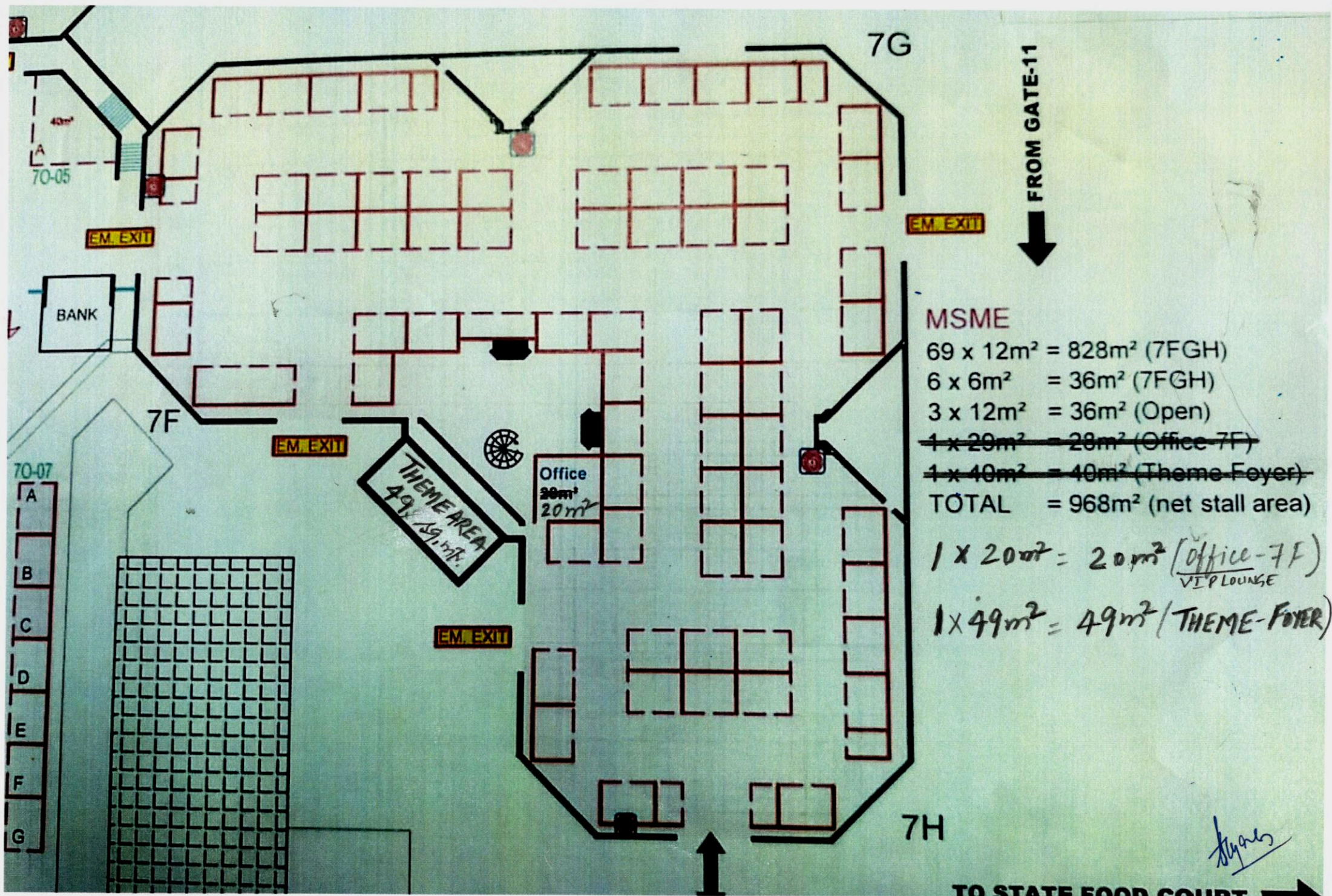

Also in the layout there is an office area of 28 sqm but in the tender VIP lounge area is 20 sqm. Kindly clarify which area to take & exact dimensions with how much side these areas are open.	The Theme-Foyer marked as 40 sqm in the Indicative Floor Plan of the said tender may be read as 49 sqm and VIP Lounge marked as 29 sqm in the Indicative Floor Plan as 20 sqm. Theme Pavilion will be three side open and VIP Lounge, will be closed on all sides with entry & exit gates on one side.
