General Terms and Conditions

Separate sealed tenders with 120 days validity from the date of opening of tenders are invited by NSIC Technical Services Centre (NTSC), New Delhi-110020, to let out the office space on lease in NTSC complex in Single stage, two envelope method, Technical Bid as well as Financial Bid in separate envelopes. Details of available spaces are mentioned in the Tender Document.

The space shall be allotted to the highest eligible Bidder subject to the approval of Competent Authority. However, NTSC existing tenants will be given a chance to match the highest Bidder if the quote of existing tenant is within the range of 15% of the highest Bidder. In case of tie/equal price in the bidding process, the existing tenant will be given preference.

- ➤ Lease rent will be charged on the super built-up area of the Demised Premises. The Super built-up area will be equivalent to 1.35 times of Carpet area of the Demised Premises, which will be measured in the presence of representative of successful Bidder(s).
- ➤ Housekeeping and maintenance of the common area shall be undertaken by NTSC Okhla. However, the allottee shall be responsible for housekeeping and maintenance of the area allotted to them.
- ➤ Registration money will be payable by the unit. The registration money should be payable through DD/ RTGS /NEFT in favouring "NSIC Ltd. NTSC A/c" payable at New Delhi. In this case no interest on registration money will be paid.
- ➤ In case of successful applicants who have been allotted the space, the registration money will be adjusted against their Security Deposit. In case the applicant withdraws application either at processing stage or after issuance of allotment letter or does not take possession of the allotted premises before the stipulated date mentioned in the allotment letter, its allotment of space will automatically stand cancelled and registration money will be forfeited. In case, NTSC Okhla refuse the application on valid grounds, the registration money will be refunded without any interest. However in case of unsuccessful Bidder the same shall be refunded without interest after opening of the bids.

Any financial bid below the reserve price i.e. Rs 82/- per Sqft per month excluding GST on super built up area, will be rejected.

- NTSC has the exclusive right to accept or reject the bid without assigning any reasons.
- The office space will be leased out after removal of belongings of existing tenants. All other work such as white washing, electric fittings and any other fitting required (if any) for use of the said space shall be done by the successful Bidder at his own cost with prior permission in writing from General Manager, NTSC.
- ➤ The Bidder will not make any structural alterations into or upon the space or make any alterations or addition to the external appearance or any part of the space without prior consent in writing.
- Authorized employee of NTSC shall be allowed to enter into the office at any time for inspection.
- ➤ The lease agreement shall be executed for three years initially which may be extended further as per policy of the Corporation. The rent shall be enhanced by 5% every year.
- ➤ The successful Bidder(s) shall submit the interest free Security Deposit (refundable) for an amount equivalent to six months' rent through Demand Draft in favour of "NSIC Ltd. NTSC A/c" payable at New Delhi within 15 working days from the date of issue of acceptance letter to the successful Bidder.
- ➤ The Power supply connection shall be provided by NTSC near the allotted space however <u>power cabling</u>, <u>metering</u> & <u>other related work shall be the responsibility of the successful Bidder</u>. All electricity and water charges shall be borne by the Bidder on the actual consumption basis at prevailing rate.

- ➤ Either party may cancel the lease deed at any point of time by giving an advance notice of 90 days.
- ➤ The security arrangement of the allotted space shall be the responsibility of the Bidder(s) and NTSC shall not be responsible for any loss or damage of the belongings lying in the aforesaid space.
- ➤ The successful Bidder(s) has to execute a Lease Agreement in prescribed format provided by this office. The expenses towards the registration shall be borne by the successful Bidder.
- ➤ The Bidder(s) shall abide by all rules and regulation of statutory bodies like Pollution Control Board, Fire department and other local administration notifications etc. for setting up of the Office.
- ➤ The Office Space shall be used by the Bidder(s) only for the purpose for which it has been allotted and not for any other purpose. The said Office Space shall not be Sublette to any other agency/firm in any condition.
- ➤ Any structural change/modification in the allotted space is not allowed. However minor repair & renovation work can be carried out subject to approval of the competent authority.
- ➤ In case Bidder wants to vacate the Office before the expiry of lease period, they can do so by serving 90 days' notice or depositing an amount equivalent to three months' rent.
- ➤ In case the Bidder(s) commits breach of any of the terms and conditions as mentioned above and contained in the agreement, NSIC has the right to terminate the agreement and the Bidder shall vacate the premises immediately and hand over the vacant possession without any protest.
- ➤ The Bidder(s) shall comply all applicable law such as Factory/Labour/Wages Law etc. as per applicable rules of local State/Center Govt.
- ▶ **PAYMENT TERMS:** The Bidder(s) shall pay the rent in advance by 10th of every month. If the Bidder(s) fails to pay the rent and other charges within the stipulated period, the Bidder(s) shall be liable to pay the interest @18% p.a. to the lessor. However, such delay in payment of rent /other charges cannot be exceeded more than two months from the date of issuance of bills failing which the allotment of space will stand automatically cancelled and the party will hand over the vacant possession of office space to NTSC. The party shall be liable to pay rent/other charges along with interest till handing over the vacant possession of the space to the NTSC.
- > The Bidder(s) shall not be allowed to encroach the area other than the allotted area by way of dumping any material or any other way. If allottee is found to be doing so, his allotment shall be cancelled and security deposit will be forfeited.

Except where otherwise provided for in the contract, all questions and disputes relating to the meaning of the words, terms, specifications, operations, and instructions, mentioned in this contract and as to the performance of the contract, any other question, claim, right, matter, or thing whatsoever in any way arising out of or relating to the contract, specifications, orders or these conditions; or otherwise concerning the performance of the contract, the execution or failure to execute the same whether arising during the existence of the contract or after the termination of the contract, the same shall be referred to the sole arbitrator appointed by the Competent Authority of the Corporation.

The venue of arbitration shall be such place as may be fixed by the Arbitrator in his sole discretion. 

Layout Plan- 1






