TERMS AND CONDITIONS FOR SALE OF SCRAP & UNUSABLE ITEMS ON “AS IS WHERE IS BASIS”

1. The scrap items /s as per the sheet are offered for sale on “as is where is basis” without any guarantee as to the condition of any item to be sold. The purchaser shall not be entitled to raise any objection on the ground that the general description of the scrap items/s does not tally with the items or any item does not tally with the items of which delivery is affected. The description of the items is believed to be correct and sold with the assumption that the purchaser had inspected it. The purchaser is not entitled to raise any objection at a later date regarding the description, condition quality of the items or for non-delivery of any items.
2. Sealed offers super-scribed “TENDER FOR SCRAP ITEMS”, addressed to Senior Branch Manager, The National Small Industries Corporation Limited (NSIC), 422, Anna Salai, Chennai – 600 006 will be received upto 4.00 p.m. on 01.03.2022.
3. Interested parties may inspect the scrap items /s at the place mentioned in the tender schedule.
4. The Corporation reserves the right to reject any or all tenders without assigning any reason whatsoever.
5. Every tender shall be accompanied by means of a Demand draft as **Earnest Money of Rs.2000/- (Two Thousand Rupees only)**. The draft shall be in favour of **National Small Industries Corporation Ltd.** payable at **Chennai** drawn on any scheduled bank. Tender not accompanied by Earnest Money shall be out rightly rejected.
6. The earnest money Deposit shall remain with the Corporation till the award of tender. It will be adjusted towards the total value of the items in case of successful tenderers and will be returned to the unsuccessful tenders within 30 days from award of Tender. No interest shall be payable on this amount.
7. The earnest money of the successful Bidder will be adjusted against the offer price accepted by the Corporation. The balance amount shall be deposited by the successful Bidder within 10 days in the form of Demand Draft from the acceptance of offer by NSIC. NSIC shall issue Delivery Instructions to lift the scrap items once the full amount is submitted by the successful Bidder to NSIC. The successful Bidder shall take delivery of the SCRAP ITEMS /s in the presence of coordinator from NSIC within a period of (5) five days from the date of issue of the delivery instructions. Bidder to note that no explanation for shortage or defects in the Scrap items/s offered for delivery shall be considered as an excuse for its non-acceptance.
8. The successful tenderer will get the earnest money forfeited if he/she fails to remit the balance amount within the stipulated time. The Corporation reserves to itself the right to charge @Rs.50/- per day after the expiry of the stipulated time (which is 5 days from the date of payment of the value of goods offered), until its final removal and this further removal period still shall not exceed (5) five days from the ORIGINAL completion time



granted for removal of goods. **Time is the essence of this Tender**, after the passing of these specified times, the Corporation reserves the right to dispose off the scrap items to the next highest tenderer or any other party, without any reference to the previous tenderer, who will make good any loss incurred by the Corporation on account of his refusal to take delivery of the scrap items.

9. GST etc. (as applicable) shall be borne by the Bidder.
10. The last date for the receipt of the tender is **01.03.2022 at 3.00 p.m.** The tenders received after the above said time and date will not be considered.
11. The tenders will be opened at the given address at **4.00 p.m. on 01.03.2022.** The tenderers or their representatives are requested to be present at the time of opening of the tenders.
12. The price offers should remain valid for acceptance for 30days from the due date of opening of the tenders.
13. The offers should be made in the format attached. Offers not submitted in the prescribed format will be summarily rejected.
14. The decision of the Corporation shall be final and binding on the Tenderers.
15. The Bidder shall observe the highest standard of ethics including laws against fraud and corruption in force in India namely "Prevention of Corruption Act 1988", during the execution of this contract. If the Bidders are found in Bid pooling, cartelization or against law on fraud and corruption then their firms may be blacklisted.
