BACKGROUND:-

I Social Interventions initiatives undertaken by NSIC under CSR Projects/ Activities need to be assessed on the following parameters:

- Reach-out and Efficacy of Interventions taken up
- Accrual of Project impact on Target Population
- Current Status and Progress of Projects supported.

This would help NSIC to comprehend the following:

- Achieving desired project output and outcome,
- Impact of CSR projects on intended / targeted beneficiaries in Project areas.

II. Broad Framework of the Assignment:

The following methods should be followed by the Agency while conducting the assigned evaluation assessment:

- Interaction with Official(s) of NSIC at the field level by visiting the concerned field office by the key personnel(s) of the agency whose name has been provided with this quotation in the technical bid. The list of field offices required to be visited by the successful bidder are located at Jaipur, New Delhi, Hyderabad, Bangalore, Ludhiana, Jalandhar, Faridabad, Chennai, Nagpur, Kanpur, Noida, Ahmedabad, Lucknow, Howrah and Bhubaneswar. The details of CSR Projects executed during 2016-17 is placed at Annexure-I
- Interaction with official(s) at Head Office level, if required.
- Interaction with beneficiaries, functionaries of the executing agencies / implementing partners, and any other sources deemed fit for collecting information for the assessment.
- Review of records / documents of CSR Projects maintained by executing agencies or Implementing Partners / NSIC.
- Preparation of standard questionnaire for the organization & beneficiaries in consultation with NSIC for obtaining information on the same, if required.
- Preparation and submission of the draft and final report.

CSR projects need to be evaluated individually at the desired location(s) as the deliverables are expected for individual projects.

- **III.** The following deliverables are expected from the Agency under the assessment:
 - A detailed study report with summary on effectiveness of the CSR projects and its impact with reference to the objectives as provided by NSIC for the purpose should be completed within a period of 120 days w.e.f. date of the Sanction letter / Work Order issued by NSIC.
 - The report should also contain Case Studies and Success Stories of CSR projects evaluated.
 - Database, if any of Draft Report & Final Report, both soft and hard copies.
 - Photographs of the activities, sites, areas, events evaluated should be incorporated in the report,

IV. Time Frame:

 The exercise should be completed within a period of 120 days w.e.f. date of the Sanction letter / Work Order issued by NSIC.

V. Data to be provided by NSIC to the successful bidder:-

NSIC shall provide the following to the Agency to effectively carry out various tasks under the Assessment:

• A list of CSR Projects to be evaluated with details of names of the executing agencies / Implementing partners and contact details. The evaluation of the CSR Projects would be co-ordinated by the concerned field office(s) and Head office, if required.

VI. Terms and Conditions of the Evaluation:

To assess the impact of the CSR Projects.

VII. Payment Terms:

The successful bidder / agency approved would be paid in the following manner:

1 st Installment	:	40% of the quoted amount on receipt of the Draft Report along with the payment request.	
2 nd and Final	:	Balance 60% of the quoted amount on receipt of	
Installment		copies of Final Report as approved by NSIC along with the payment request.	

VIII. Eligibility Criteria

- Organizations having minimum three years of experience in the field of evaluation / impact assessment of Corporate Social Responsibility (CSR) projects of CPSEs of costing not less than Rs. 1.00 Lakh in each year. Proof as regards the same should be submitted along with the Technical bid.
- The eligible agency applying for appointment should have a valid registration certificate with Government of India and should be submitted with the Technical bid.
- The last three financial years accounts should have been audited. Audited Accounts along with Auditor's Report should be submitted with the Technical bid. Submission of Auditor's Report is mandatory.
- The eligible agency would provide list of key personnel(s) having experience in the field of evaluation/ impact assessment of CSR Projects / activities who would be involved under CSR evaluation mechanism and should be submitted with the technical bid. The number of key personnel(s) should not exceed 5 numbers. In case if the agency is having Offices PAN India, then the List of Offices located across India along with name(s) of Key personnel(s) posted who would be involved in CSR evaluation mechanism should be submitted with Technical bid.
- The organization should have a Permanent Account Number (PAN) and should be submitted with Technical bid.
- The organization should have been in existence for the last three full years.
- All the valid certificates should be submitted along with the Technical specifications otherwise the quotation will be out-rightly rejected.
- The Competent Authority reserves the right to reject all or any quotation(s), wholly or partly, without assigning any reason whatsoever.

TERMS & CONDITIONS

- 1. The sealed quotation shall be submitted in accordance with these instructions and any quotation not conforming thereto is liable to be rejected. These instructions shall form part of the quotation.
- 2. The quotation shall be submitted in two sealed covers separately i.e. "Technical Bid" and "Commercial Bid" superscribed with the name of work, due date of submission, in the following manner: -

a) Technical Specifications:

One sealed cover superscribed as "Technical Specifications for conducting the assigned evaluation of CSR projects for the year 2016-17" containing the acceptance of Technical specifications and documents as per check list enclosed herewith.

b) Commercial Specifications:

One sealed cover superscribed as "Commercial Specifications for conducting the assigned evaluation of CSR projects for the year 2016-17" containing quoted rates in Indian National Rupees (words & figures both) plus applicable taxes as per law with details and documents as per commercial specification enclosed herewith.

In case, if the Commercial Bid is not enclosed in a separate sealed cover but included in technical bid, such quotations will be out rightly rejected.

- **3.** Price quoted in Commercial Specification—should be consolidated sum covering all expenses like remuneration / fee, travelling and lodging & boarding etc. plus applicable taxes as per law.
- 4. In the event of discrepancy in the rates, written in words and the figures, the rates quoted in words will be considered.
- 5. Only technically qualified quotations will be considered eligible under commercial specifications.
- 6. The technical quotation will be accompanied by Earnest Money of Rs.10,000/- (Rupees Ten thousand only) by way of Demand Draft in favour of "The National Small Industries Corporation Ltd." payable at New Delhi . Micro and Small Enterprises are exempted from payment of Earnest Money as per Public Procurement Policy for Micro and Small Enterprises (MSEs) Order,2012 on submission of valid adequate proof with the Technical bid.

The Earnest Money of Rs. 10,000/- (Rupees Ten thousand only), if deposited of the successful quotation will be converted as part of Security Deposit for performance of the contract after award of tender. In case of non-acceptance

- of the technical quotation the earnest money will be refunded. The Earnest Money will not carry any interest.
- 7. All documents submitted with the quotation shall be in English and / or Hindi language only.
- 8. The quotation shall remain valid for 180 days from the date of opening of quotation(s) unless otherwise stipulated.
- 9. Telegraphic or Tele fax quotation(s) will not be accepted.
- 10. Before submitting the quotation, the party, if required may visit the NSIC Office to acquaint with the nature of the work and may obtain all necessary information which may influence or affect his quotation.
- 11. Successful bidder will have to deposit an additional amount of Rs. 15,000/- (Rupees Fifteen thousand only) totaling Rs. 25,000/- (Rs. Twenty five thousand only) (refer clause 6) towards security deposit which will also not carry any interest. However, the successful bidder who has not deposited Rs. 10,000/- towards Earnest Money would be required to deposit Rs. 25,000/- (Rs. Twenty five thousand only) towards Security deposit which will also not carry any interest.
- 12. The total time allowed for completion of the work from the date of order is to be adhered and if the party fails to submit *Evaluation Report* or to perform the services within the period(s) specified in the contract, NSIC shall, without prejudice to its other remedies available under the Contract, deduct from the Contract Price, as liquidated damages of @ Rs.250/- per day for the period of delay from the due delivery date. In addition to this the Corporation shall also have the right to get the work completed from other sources at the cost, risk and responsibility of the bidder if the *Evaluation* Reports are not received to this office within the *stipulated period*.
- 13. Successful bidder shall have to submit the Hard and Soft Copy of draft evaluation report and twenty Hard copies of Final Evaluation Report along with a soft copy of the same at NSIC, Company Secretary Division at his own cost.
- 14. Full & final payment shall be made within 60 days on satisfactory completion of the work and *submission of the Final Evaluation Report* after deducting the amount as per the applicable laws.
- 15. Security Deposit of Rs. 25,000/- (Rs. Twenty five thousand only) will be refunded to the successful bidder only after satisfactory completion of job.
- 16. The visit to all the field offices is mandatory only by the key personnel(s) whose names are provided with this quotation. In case if the field offices are not visited by the successful bidder within the stipulated time, it will lead to cancellation of contract, forfeiture of security deposit as well as blacklisting of the firm.

- 17. The firms blacklisted by Govt. agencies are not eligible for participation in this tender.
- 18. The Competent Authority reserves the right to reject all or any quotation(s), wholly or partly, without assigning any reasons whatsoever.

19. ARBITRATION

All disputes, differences and questions arising out of or in any way relating to or concerning with this tender or subject matter thereof or the representative rights, duties or liabilities of the parties shall be referred to the sole arbitration of the arbitrator appointed by the Competent Authority of NSIC or any person nominated by him. The arbitration shall be in accordance with the Arbitration and Conciliation Act, 1996. The arbitrator shall be entitled to extend the time of arbitration proceedings with consent of the parties. No part of the tender shall be suspended on the ground of pending arbitration proceedings. The Arbitration proceedings shall be held in New Delhi.

This tender shall be governed by and interpreted in accordance with the laws of India and subject to jurisdiction of Courts in New Delhi.
