- 1. Quotation has to be submitted in sealed envelope superscribing "Quotation for façade cleaning" on or before 28-05-2012. Quotation received after due date shall not be considered for opening and same shall be summarily rejected
- 2. Parties submitting their quotation are advised to visit the site and acquaint themselves about the nature of work and site conditions. Non familiarity with site condition shall not be construed reasons for increasing the rates after accepting offer of the party.
- 3. The work has to be carried out in neat and tidy manner to the satisfaction of the In-charge and all care has to be taken to ensure that no part of the building get damage during execution of works. Materials used for carrying out the work shall be of standard quality. Work has to be completed in all respect within 15 days from the date of issue of work order to party.
- 4. Cleaning as mentioned in the schedule has to be carried out at interval of 4 months or as per the direction of In-Charge.
- 5. Quantity mentioned in the enquiry performa is tentative only and the work has to be carried out as per the site conditions and as per direction. Amount shall be released after completion of work in all respect and as per actual quantum of work executed. Necessary statutory deduction as applicable shall be effected from the payment. No advance payment whatsoever shall be made.
- 6. An amount equivalent to 5% of value of work done shall be deducted from the each bill and same shall be released to them after completion of subsequent cleaning.
- 7. The amount quoted shall be inclusive of all labor, materials, taxes, duties, transportation, insurance of the workmen etc. complete.
- 8. The party shall be fully responsible for any damage or injuries happens to their workmen deployed for carrying out the work at site and NSIC has nothing to do with the same. The party shall also be fully responsible for compliance of all statutory labour laws like ESI, PF, insurance etc. as per prevailing norms and NSIC shall in no way be held responsible for non-adherence of the same by the party.
- 9. The quotation submitted should be valid for a period of 90 days from the last date of opening of quotation. The rate quoted shall be valid for a period of 2 years from the first cleaning i.e the party has to carry out seven repeated cleaning on the same rate as quoted by them.
- 10. The work shall be carried-out in the working office area and hence party shall take all necessary safety precautions during execution of the works and ensure that no un-due disturbances caused to the working people.
- 11. The party shall be fully responsible for any injury or accident happened to the workmen employed by the party for carrying out the works and NSIC shall no way be held responsible for the same.
- 12. The party shall be fully responsible for the safety and security of the materials brought to site by them for carrying out the works. Subject to availability, NSIC may provide space for storing the materials at the risk and cost of the party.
- **13.** The Party shall enclose necessary credentials for the similar kind of works executed by them in last 3 years.
- 14. NSIC reserves the right to accept any or reject all the quotations without assigning any reason thereof.
- 15. Conditional offer will not be accepted & will be summarily rejected.
