## **Terms & Conditions**

1. The quotation in sealed envelope, superscribing “QUOTATION FOR INTERNAL PAINTING WORK” should be submitted at the above address, on or before 19-09-2008. The quotation received after due date shall be summarily rejected.
2. The quoted rate shall be inclusive of all materials (consumables and non-consumables), DDL binders and robin blue (For white washing), labour required for carrying out the work, loading-unloading, transportation, taxes, duties, and scaffolding etc., and shall also includes those items which are not specified but required for completion of the works.
3. The necessary crack repairing work in the wall surface including making necessary groove, applying putty or filling sealant powder, wherever required shall be carried out by the party and nothing extra shall be paid for the same.
4. The work shall be completed within three weeks from the date of confirm work order.
5. Payment shall be released after satisfactory completion of the woks in all respect. Necessary Statutory deduction as applicable shall be made from the amount payable to the party.
6. The materials used for the work shall be of the approved shade/colour, brand & the work shall be carried out professionally and neatly.
7. Parties are requested to make a visit to site and fully acquaint themselves about the site conditions, nature of works to be carried out. Non-familiarity with the site condition shall not construed or attract for increase in rates if any, after acceptance of quoted rates.
8. The work executed shall have 6 months defects liability period from the date of completion and any defects noticed during this period shall be rectified by the party free of cost.
9. Deputy General Manager reserves the right to accept any or reject all the quotations without assigning any reason thereof.
10. The party shall take all safety precautions during the execution of the works and shall ensure that no part of the building shall be damaged.
11. The party shall be fully responsible for any injury or accident happened to the workmen deployed by them for carrying out the works and NSIC shall no way be held responsible for the same.
12. The parties are required to submit/enclose their credentials along with the quotation.
13. The work shall be executed inside the premises of NSIC TSC and hence the rules and regulation applicable, shall be binding upon the party.
14. Also, the work is to be carried out in the working office and party shall exercise all necessary to safe guard fittings, fixtures, furniture etc. and shall carry out the work in such fashion that shall not hamper or create any inconvenience during working.
15. Any party if desires, can down load the enquiry Performa from the NSIC web site and can submit the same in sealed envelope, before due date.
16. Quantities mentioned above are tentative only and the work shall be carried out strictly as per site condition and direction. The payment shall be released as per actual quantum of work executed after effecting necessary statutory deduction if any.
