Sir,

Sealed Tender documents are hereby invited from the interested parties for disposal of Mobile Gantry Crane (**in non-working condition**) installed at NSIC Technical Services Centre (NTSC), Okhla Industrial Estate, New Delhi-110020 on the following terms and conditions:

1. The tender document shall be issued from 16.11.2015 to 30.11.2015. The last date for submission of tender is 30.11.2015. The tender fee is Rs.500/- and shall be paid in form of DD/Pay Order favouring **NSIC Ltd A/c NTSC**. The intending tenderers can also download the complete tender document available on the web site www.nsic.co.in and submit the same along with tender fee, requisite earnest money deposit and supporting documents by the due date. The tenderers/units registered with Central Purchase Organization i.e. DGS&D, National Small Industries Corporation Ltd (NSIC) or with the concerned Ministry or Deptt. Shall be exempted from the payment of earnest money and tender fee as defined under rule 157 of General Financial Rules (GFR) 2005
2. Tenderers are advised to acquaint themselves fully with the nature of work, time schedule and terms and conditions including all the provisions of the tender document before submitting their tender.
3. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to nature of work, site conditions, means of access to the site etc. Non-familiarity with the site conditions will not be considered a reason either for extra claims or for not carrying out the work in strict conformity with the specifications. For site visit and any clarification / information/Assistance, the intending tenderers may contact manager (P&A) **NSIC Technical Services Centre, (NTSC), Okhla Industrial Estate, New Delhi-110020.**
4. The Mobile Gantry Crane shall be disposed off on **"AS IS WHERE IS BASIS"**. Party shall make their own arrangement for dismantling; stacking etc. and nothing on this account shall be paid by NTSC
5. The rate shall be quoted on the prescribed Proforma attached as **Annexure-A.**
6. The rates quoted shall be all inclusive of all taxes, duties etc.
7. The item shall be disposed off to the highest bidder. However NTSC can accept any tender without assigning any reason

8. The party submitting their tender shall enclose a D D/Pay Order (Favouring NSIC Ltd A/c NTSC) equivalent to 10% of their quoted amount as Earnest Money Deposit. The (EMD) and the said amount deposited by the successful bidder shall be retained and considered as security deposit. However, the EMD amount of unsuccessful bidders shall be returned to them within 15 days from the date of opening of tender or placing order on the successful bidder, whichever is later.
9. The EMD deposited by successful bidder shall be converted into security deposit and the same shall be refunded within 15 days of delivery of goods. In case the unit is exempted for the deposit of EMD, the said unit shall deposit 10 % of the bid value as security deposit within 3 days from the date of confirmation letter from NTSC informing successful bidder selection
10. The parties submitting their tender document should enclose the copy of
 - i) The copy of registration certificate for claiming EMD exemption,
 - ii) Copy of the PAN Card.
 - iii) Copies Sales tax, VAT/TIN registration certificates
11. The party selected for disposal of the items shall deposit the amount (Total Bid Value) based on estimated quantity, within 7 days from the receipt of the demand note from NSIC- Technical Services Centre, Okhla New Delhi. After making the full amount, party shall make necessary arrangement for dismantling and removal of the Mobile Gantry Crane and complete the work in all respect within 15 days from the date of awarding the order. However, actual weighing shall be done by the Officer In charge, NTSC, Okhla at the approved weigh bridge to calculate the total amount payable by successful tenderer All cost of transportation, weighing etc. shall be borne by the tenderer.
12. In case party fails to pay the amount and complete the work within the stipulated time, the Security amount deposited by the party shall be forfeited and NTSC shall be at liberty to dispose the materials to other party. The NTSC shall have full right to take any unwanted action if the party failed to complete the work within stipulated time
13. NTSC, Okhla reserves the right to reject any or all the tenders without assigning any reason thereof and accept any tender without assigning any reason
14. Canvassing whether directly or indirectly in connection with tender is strictly prohibited and the tender submitted by the contractors who resort canvassing will be liable to be rejected.
15. Tenderers are advised to submit the tender strictly based on the terms and conditions contained in the Tender Documents and not to stipulate any deviations. Conditional tenders are liable to be rejected.
16. Tender submitted by tenderers shall remain valid for acceptance for a minimum period of 60 days from the date of opening of the tenders. The tenderers shall not be entitled during the said period of 60 days, to revoke or cancel their Tender or to vary the Tender given or any term thereof,
17. **ACCEPTANCE / REJECTION OF TENDER**
 - i). The tender shall be awarded based on the highest offer received. However NTSC can accept any tender without assigning any reason

- ii). Corporation also reserves the right to accept or reject any tender in part or full without assigning any reason whatsoever.
 - iii). Corporation also reserves the absolute right to reject any or all the tenders at any time and the opinion/decision of NSIC-TSC regarding the same shall be final and conclusive.
18. The rates quoted by bidder shall remain firm till completion work in all respect
19. Any addendum/ corrigendum issued shall form a part of the tender document. There will not be any press notification on amendment/ corrigendum. The purchasers of the tender document/ the prospective tenderers are required to visit NSIC website and CPP Portal for all such amendments/ corrigenda to this Tender as well as the tender document.
20. The contractor shall be bound to follow all such restrictions/instruction from NTSC & nothing extra shall be payable on this account.
21. The work shall be carried out in coordination with the other contractor (s) working inside the building so that during demolition process, their progress of work does not suffer and also the work being carried out by the other contractor (s) does not get damage.
22. The contractor shall be fully responsible for the any injury or damage caused to the workmen deployed by him at site for carrying out the work and Corporation has nothing to do with such happenings and in no way shall be held responsible for the same.
23. All the pages of tender document should be properly signed and sealed while submitting the bid against this tender
