#### **COMMERCIAL AND GENERAL TERMS & CONDITIONS**

#### 1. Submission of tender:

Sealed tenders in the two cover system should be submitted in the prescribed form and should be addressed to the General Manager, NSIC-Technical Services Centre, Okhla Industrial Estate, Phase III, New Delhi-110020. The bigger envelope must be super-scribed "Tender for the supply & Installation of MSC Nastran & MSC Adams Software — University MD FEA bundle" with tender inquiry number and its due date. The two sealed envelopes inside the bigger envelope must be as under:

- i) Envelope No-1: The said envelope is for technical bid & shall be superscribed as "Tender for the supply and installation of MSC Nastran & MSC Adams Software – University MD FEA bundle – Technical Bid"
- **ii) Envelope No-2:** The said envelope is for commercial bid & shall be super scribed as "Tender for the supply and installation of MSC Nastran & MSC Adams Software University MD FEA bundle Commercial Bid".

#### 2. Authority of tenderer:

The Bidder shall be an OEM/ Authorized Dealer/ Authorized Distributor of the said software to deal with NSIC Technical Services Centre, Okhla Industrial Estate, Phase-III, New Delhi.

#### 3. Duly filled in Tender:

All the columns of the tender shall be duly filled in. Any cutting/over writing in the tender must be signed by the person who is signing the tender. The rates shall not be overwritten. The financial part in commercial bid shall always be both in figures and words. In case of any discrepancy, amount mentioned in words will be considered for evaluation.

### 4. Rejection of Tender:

While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any Tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.

#### 5. Earnest Money Deposit:

- a) An EMD of Rs. 17,000/- (Rupees Seventeen Thousand Only) shall be paid along with the tender (in Technical Bid) either by way of Cheque/DD drawn in favour of 'NSIC Ltd.-NTSC A/c' payable at Delhi. The EMD will be returned to the unsuccessful bidders after the orders are placed on the successful bidder. The unit registered with Central Purchase Organization i.e. DGS&D, NSIC or with the concerned Ministry or Dept. shall be exempted from the payment of earnest money under rule 157 of GFR, 2005. In such cases, the necessary certificate has to be enclosed along with the Technical Bid.
- b) The EMD will be forfeited in following cases:
- I. If the bidder fails to supply the equipment with specifications in compliance to as mentioned in Annexure –B with in stipulated time.
- **6. Bid Price:** The price shall be firm and shall include all applicable taxes and other charges. Any variation in the taxes duties, levies, charges, insurance etc. till the delivery of software shall be to the Tenderer account.
- **7. Validity of tender:** The tender shall be valid for a period of 45 days from date of opening of the Technical Bid of tender.

# 8. Opening of Technical Bid:

The Technical Bid shall be opened on 18<sup>th</sup> October, 2016 at 16:00 hours, at office of the General Manager, NSIC-Technical Services Centre, Okhla Industrial Estate, Near Govindpuri Metro Station, New Delhi-110020. One of the authorized representatives of the bidder may present at the time of opening of the tender.

#### 9. Opening of Commercial Bid:

Commercial Bid of technically qualified tenderer will be opened on stipulated due date. The date & time for opening of Commercial Bid shall be intimated to the qualified tenderers. One of the authorized representatives may be present at the time of opening of the Commercial Bid.

### 10. Delivery:

- a) The successful tenderer shall complete supply within 21 days after issue of the award letter.
- b) The latest version of the software which is available in the market is to be delivered at NSIC Technical Services Centre, Okhla Industrial Estate, Phase III, New Delhi along with all necessary documents. The user name and password also be given to download from OEM website.
- c) The liability of installation and testing shall lie with the tenderer.
- d) A document supporting the license type / validity & genuineness of software shall be submitted with delivery of license.
- **11. Packing:** The software shall be supplied in CD. Defective or broken CD will not be accepted.

#### 12. Payment:

- a) 80% payment will be made by the Corporation by account payee cheque subject to:
  - i. The tenderer sending bills in duplicate (original + copy) giving the reference number of the supply order.
  - ii. The tenderer shall submit the document which shall clearly indicate proper installation and testing of software duly certified by workshop in-charge.
- b) The balance 20% payment of total bill value will be released to supplier:
  - i. After 06 (six) days training on all functions of software supplied.
- **13. Service Facility:** In order to ensure proper and timely after sales service, manufacturer or authorized agency shall have network to deploy service personnel at short notice and attend to the maintenance.

### 14. Warranty Period:

The software offered shall conform to the warranty period of minimum 12 months from the date of installation. During warranty period, the tenderer shall give software upgrade, trouble shooting, maintenance and upgrade familiarization training on new release/features if any for the smooth functioning of the software.

- **15.** The General Manager, NSIC Technical Services Centre reserves the right to reject the tender/ bid wholly or partly without assigning any reason and to restrict the list of qualified Tenderer for opening of commercial bid to any number deemed suitable by him from out of bids received.
- **16.** In the event of any dispute the legal matter shall be subjected to the jurisdiction of Delhi Court only.
