In case quality of the work executed by the contractor is found to be poor, NSIC reserves the right to impose suitable penalty / liquidated damages including rejection of the materials supplied, blacklisting of the agency or any other action as deemed fit by NSIC. Liquidated Damages @ 2% of the value of work order shall be levied on the agency for each day of delay in completion of the work subject to a maximum of 10% of the value of work order.
5. No ad-hoc/ interim payment shall be released. Payment shall be released only after satisfactory completion of work.
6. The payment shall be released subject to statutory deductions, as applicable.
7. NSIC reserves the right to reject/cancel one or all offers without assigning any reason.
