1. Input

NSIC will hand over the hall no. 14 at Pragati Maidan to the selected security agency from 10th Nov. 2009 onward for security of Techmart India 2009.

2. Security:

The NSIC exhibition is visited by high profile dignitaries /High Power delegation/VIP's both from India and abroad. The selected agency will be responsible for the entire security of the hall No. 14 for the exhibition period (14-27th Nov.'09).

3. Rates:

Quoted rates should be inclusive of all tax including service tax.

4. Payment terms

5. Penalty:
