Sealed offers are invited from experienced/ reputed security agencies for providing security during Techmart India 2015 from 14-27 November, 2015 at Hall No. 14, Pragati Maidan, New Delhi to be organized by NSIC. Our tentative requirement for Security Supervisors(Ex-Servicemen) / Security guards for the 3 shifts are as given below.

**Interested Agencies may quote rates for Security Supervisor (Ex-servicemen), Security Guard, Lady Guard / Searcher and Un-skilled Manpower (for day to day work) for per 8 hours shift in the schedule enclosed herewith as ANNEXURE-1.**

**1. Input**

NSIC will hand over the hall no. 14 at Pragati Maidan to the selected security agency from 10<sup>th</sup> Nov. 2014 onward for security of Techmart India 2015.

**2. Security:**

The NSIC exhibition is visited by high profile dignitaries /High Power delegation/VIP's both from India and abroad. The selected agency will be responsible for the entire security of the hall No. 14 for the exhibition period (14-27<sup>th</sup> Nov., 2015).

3. **Rates:** Quoted rates should be inclusive of all tax including service tax.

4. **Payment terms**

No contingency payment is admissible. Payment will be released only after successful completion of the work and acceptance of the same by Corporation. The payment shall be released after deduction of all statutory dues.

5. **Penalty:**

In case of breach of security or any other mis-happening NSIC reserves the right to impose suitable penalty, or any other action deemed fit by NSIC, Head Office, New Delhi including black listing of agency with State Authorities. Penalty will also be imposed if the time schedule is not met. Two percent of the value of the order will be charged as penalty amount for each day of delay after the scheduled time. However, the maximum penalty is limited to 10% of the value of the order.

**B. General terms & conditions**

1. The agency shall deploy ex-servicemen security guards and supervisors both in the day and night shifts as per our requirement. In case, we find deployment of guards/supervisors other than the above category, the payment of the guards/supervisors will be restricted to the un-skilled worker's wages and the contract of the agency shall also be liable to cancellation.
2. You shall be responsible for payment of all wages, allowance, overtime, washing allowances, EPF/ESI/LTC, medical and other statutory benefits admissible to your employees directly.
3. You shall also abide by the regulations governing the deployment of guards viz. Minimum Wages Act, Labour Act etc.
4. You shall be responsible for all losses/shortages to the pavilion or the materials stored and the same shall be made good by you.
5. The Agency shall not sub-contract the services of personnel engaged by them.
6. The Agency will provide to its staff complete uniform and other accessories i.e. touch, whistle baton etc.
7. The Agency shall also ensure that no workman/Guard below the age of 18 years are deployed by him for the above mentioned jobs.
8. The Agency shall ensure that the payment of wages to the workman/guards shall be as per Minimum Wages Rate Act.
9. **You have to submit copies of the EPF/ESI registration Certificate and PAN number along with your Offer. In the absence of these documents, the quotation will not be considered.**
10. NSIC reserves the right to cancel the work in part / full without assigning any reason.
11. NSIC reserves the right to reject any / all offers without assigning any reason.

12. You shall be required to submit your bill for payment towards wages after the close of the fair.
13. The NSIC reserves the right to terminate the services of the security agency without assigning any reason whatsoever. If the security agency wants to discontinue the contract, they shall have to give 15 days prior notice in writing.
14. The strength of the security personnel to be deployed during the exhibition shall be regulated on actual need basis which shall be intimated to you from time to time.
15. The Agency shall comply all statutory dues like Provident Fund, Family Pension, ESI and other statutory dues etc. In respect of supply of Security Guards to National Small Industries Corporation Limited during Techmart India 2015 have been deposited with Statutory Authorities as per prevalent rules/act.

Further, you are also responsible for any liability and penalty arises in future or at any stage without any demur or protest on account of Statutory Dues like Provident Fund, Family Pension, ESI and other statutory dues etc. in connection with supply of Security Guards during Techmart India 2014. Any losses/damages/placed on us shall be payable to NSIC.

16. Agency selected will have to deposit Demand Draft Rs. 50,000/- valid up to 31.03.2016 in favour of National Small Industries Corporation payable at New Delhi towards security deposit. The DD of Rs.50,000/- deposited by the Agency shall be returned without any interest after successful completion of the work.
17. Your offer in a sealed envelope should be addressed to the **Dy.
