- 1. Sealed quotation superscribing "Quotation for Providing and fixing pump to the existing borewell at Rajaji Nagar, Indl Estate, Bengaluru" should be submitted on or before 13/02/2013.
- 2. Parties submitting their quotation are advised to visit the site and acquaint themselves about the site conditions and nature of work to be carried out. Non familiarity with site condition shall not be construed reasons for increasing the rates or not executing the work as per specifications, after accepting offer of the party.
- **3.** Work has to be carried out strictly as per site conditions and as per the directions of Engineer-In-Charge. Materials used for carrying out the work shall be of standard quality and brand as per the directions of Engineer-In-Charge. Work has to be completed in all respect within 10 days from the date of issue of work order. In case the party fails to complete the work within the stipulated time, NSIC shall be at the liberty to cancel the contract and execute the work through other agency.
- 4. Quantity mentioned in the enquiry performa is tentative only and the work has to be carried out strictly as per the site conditions and as per directions. Amount shall be released after completion of work in all respect and as per actual quantum of work executed. Necessary statutory deduction as applicable shall be effected from the payment. No advance payment whatsoever shall be made.
- 5. Work executed by the party shall have defects liability period of one year from the date of completion of works in all respect. Any defects noticed during this defects liability period shall be rectified by the party, free of cost.
- 6. Amount quoted shall be inclusive of all labour, materials, taxes, duties, transportation, insurance of the workmen etc. complete. It may be noted that no price preference shall be given for the items, quoted with higher specification than mentioned in the schedule.
- 7. Party shall be fully responsible for any damage or injury happens to their workmen during execution of work at site and NSIC has nothing to do with the same.
- 8. Quotation submitted should be valid for a period of 60 days from the last date of opening of quotation.
