- The Bidder shall be OEM or Authorized Distributors/ Partners/ Dealers of HP, Microsoft and Cyberoam having authorization to supply the product. A copy of Authorization letter issued by OEM to Authorized Distributors/ Partners/ Dealers attending tender to sale the Computer System, MS-Office, UPS & Firewall on behalf of OEM shall be enclosed with the Technical bid.
- 2. Tender form can be downloaded from the website <u>www.nsic.co.in</u> from 3rd December, 2013 to 26th December 2013. The cost of tender fee may be enclosed with Technical bid in the form of demand draft in favour of "<u>The National Small</u> <u>Industries Corporation Ltd</u>." payable at New Delhi.
- 3. The Earnest Money Deposit of Rs. 11,000/- (Rupees Eleven thousand only) by way of D.D. only drawn in favour of "<u>The National Small Industries Corporation</u> <u>Ltd</u>." payable at New Delhi shall be submitted along with Technical Bid.

The offers without EMD will be rejected. However, there is exemption of EMD applicable to the units registered with Central Purchase Organization (DGS&D), National Small Industries Corporation (NSIC) or the concerned Ministry or Department as defined under Rule 157 of General Financial Rules (GFR), 2005. A copy of valid certificate shall have to be enclosed along with the Technical bid for availing EMD exemption.

- 4. Tender shall be duly, properly and exhaustively filled in. All pages of the tender should be signed with stamp by the Authorized Signatory of Tenderer with company stamp on all the pages of this tender.
- 5. Any cutting/over writing etc. in the tender must be signed by the person who is signing the tender. The rates and units shall not be overwritten. The financial figures in commercial bid shall always be both in figures and words. In case of any discrepancy in figures and words, the amount written in words shall be considered.
- 6. The Tenderer shall submit the copy of PAN, TIN, VAT registration along with the Technical Bid of the tender document.
- 7. The tender shall be placed in a properly sealed bigger envelope addressed to General Manager-SG (TISDC),National Small Industries Corporation Limited, (A Government of India Enterprise),NSIC Bhawan, Okhla Industrial Estate, New Delhi– 110 020 and the said bigger envelope shall contain two separate sealed envelopes containing Technical & Commercial bids.

- 8. The bigger envelope shall be super-scribed as "Supply and Installation of Computer System, MS-Office, UPS & Firewall". TERMS & CONDITIONS

Submission of the duly signed tender implies that these conditions of tender have been read by the Tenderer and is aware of the scope of the supply and the quality of the material to be supplied. The final acceptance of the tender rests with the General Manager-SG (TISDC) of NSIC, who reserves the right to accept or reject any or all tenders without assigning any reason therefore.

- a) No representation for the enhancement of the prices of the accepted tender or alteration of the terms and conditions will be entertained at any stage.
- b) The delivery period of the supplies should be within <u>20 days</u> from the date of confirmed order from NSIC. In case tenderer fails to supply within the accepted period, penalty at the rate of 1% of value of the order, per week of delay subject to maximum of 20% of the order value will be levied.
- c) The supplier shall provide packing of the goods, as is required to prevent their damages or deterioration during the transit to their final destination i.e. National Small Industries Corporation Limited, (A Government of India Enterprise),NSIC Bhawan, Okhla Industrial Estate, New Delhi– 110020.
- d) The rates quoted shall be firm & all inclusive for delivery & installation at destination National Small Industries Corporation Limited, (A Government of India Enterprise),NSIC Bhawan, Okhla Industrial Estate, New Delhi– 110020.
- e) The Computer System, MS-Office, UPS & Firewall shall have to be operationalized without any extra cost and to the satisfaction of the Manager (TISDC) of H.O. NSIC, Okhla, New Delhi.
- f) In the case of Cyberoam Providing necessary information for appropriately configuring the ISP lines/ routers so that they may all operate in load balance mode and any other work required for making the fully functional of Cyberoam at NSIC,H.O. Okhla, New Delhi.
- g) 100% Payment will be made against successful delivery and installation for which the tenderer shall submit bills in duplicate (original + copy) giving the reference number of the supply order along with delivery note.
- h) While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected.
- i) Any request by the bidders to consider their EMD furnished by them to NSIC for any other contract/ tender cannot be considered as EMD for this tender.
- j) The EMD will be refunded to the unsuccessful bidders after the orders are placed on the successful bidder. In case of successful bidder, the EMD will be returned after three months of delivery. No interest on EMD will be paid.
- k) The EMD will be forfeited in following cases:
 - i. If the bidder fails to accept the order based on his offer within the prescribed time.
 - ii. If the bidder fails to supply the Computer System, MS-Office, UPS & Firewall with specifications in compliance to specifications given in technical bid.
 - iii. If the bidder delays supplies beyond a reasonable time resulting in disruption of NSIC works.

- k) If the Computer System, MS-Office, UPS & Firewall are found to be different than those in the accepted offer and are of specifications lower than those stipulated in the accepted offer, NSIC shall have right to totally reject the said items and claim for compensation. The supplier shall be responsible for arranging the rejected said items to be removed at his cost from NSIC premises.
- I) In the event of any dispute the legal matter shall be subjected to the jurisdiction of Delhi Court only.
- m) NSIC, as per its discretion, may procure items from one or more than one supplier, or procure items in parts or may change the quantity of items or reject entire procurement process/quotations.
