1. Tenderers shall submit their offers in a sealed cover super scribed as **"Tender for Old Machines"** at NTSC Howrah on or before **25.01.2011** up to **1 P.M.**
2. The Tender should be accompanied with the Earnest Money Deposit equivalent to 5% of the total quoted price in the form of a Demand Draft/Pay Order in favour of **"National Small Industries Corporation Ltd."** payable at Howrah. **No Cheque or cash shall be accepted. The offers without Earnest Money Deposit will be rejected.**
3. Tenderers shall take into account the cost of labour & cartage etc. before quoting the rates. In this regard no extra claim what so ever shall be entertained by the Centre.
