Supervision Services joint Inspection, Installation, Commissioning and proving Tests

The supplier shall arrange demonstration/commissioning of the Equipment after installation is done under the supervision/direction of the firm's engineers. Adequate number of teams of technical experts will be made available so that the commissioning delays are eliminate these Personnel will be required to be present as soon as the foundation is ready and Equipment is located at the site.

The supplier or his agent shall demonstrate/commission the D.G Set within 2 weeks from the date of intimation by the consignee in respect of readiness of the foundation and installation of the machine.

The D.G Set performance shall be demonstrated as per technical specification in the contract by the supplier or his agent after successful commissioning at the consignee's works. Thereafter the consignee shall use the D.G Set intensively for 2 working days, and it performance watched before the final proving test certificate.
