COMMERCIAL AND GENERAL TERMS & CONDITIONS

1. Submission of tender:

Sealed tender in single cover system (super scribed with "Supply of Semi-Automatic Washing Machine Kit") should be submitted either by hand or speed post in the prescribed form and should be addressed to the General Manager, NSIC-Technical Services Centre, Okhla Industrial Estate, Phase III, New Delhi-110020.

2. Authority of tenderer:

The bidder shall be a manufacturer of kit/Jig to deal with NSIC Technical Services Centre, Okhla Industrial Estate, Phase-III, New Delhi.

3. Duly filled in Tender:

All the columns of the tender shall be duly filled in. Any cutting/over writing in the tender must be signed by the person who is signing the tender. The rates shall not be overwritten. The financial part in bid shall always be both in figures and words. In case of any discrepancy, amount mentioned in words will be considered for evaluation.

- **4. Rejection of Tender:** While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any Tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.
- **5. Bid Price:** The price shall be firm and shall include all applicable taxes and other charges. Any variation in the taxes duties, levies, charges, insurance etc. till the delivery of goods shall be to the Tenderer account.
- **6. Validity of tender:** The tender shall be valid for a period of 30 days from date of opening of the tender.

7. Opening of Bid:

The bid shall be opened on 17th Aug 2016 at 16.00 hours, at the office of the General Manager, NSIC-Technical Services Centre, Okhla Industrial Estate, Near Govindpuri Metro Station, New Delhi – 110020. One of the authorized representatives of the bidder may present at the time of opening of the tender.

8. Delivery:

- The successful tenderer shall complete supply within 21 days after issuing of order.
- b) The equipment are to be delivered at NSIC-Technical Services Centre, Okhla Industrial Estate, Phase III, New Delhi along with the necessary & other related documents/reports for ensuring quality.

- c) The liability of kit/Jig till commissioning and testing shall lie with the tenderer.
- **9. Packing:** The kit/Jig and its accessories shall be supplied in packed condition. Defective, broken or unsealed kit and accessories will not be accepted.

10. Payment:

- a) 80% payment will be made by the Corporation by account payee cheque subject to:
 - The tenderer sending bills in duplicate (original + copy) giving the reference number of the supply order along with copies of LR/delivery note.
 - ii. The tenderer shall submit the document which shall clearly indicate proper supply, commissioning & testing of kit.
 - iii. Submission of commissioning and testing report duly certified by workshop in-charge.
- b) The balance 20% payment of total bill value will be released to supplier:
 - i. After successful training on all functions of kit/Jig supplied.
 - ii. Submission of indemnity bond on Rs. 100/- stamp paper towards commitment of supplier for services rendered during warrantee period.
- **11. Service Facility:** In order to ensure proper and timely after sales service, manufacturer or authorized agency shall have network to deploy service personnel at short notice and attend to the maintenance

12. Warrantee Period:

- a.The kit/Jig offered shall conform to the specifications as given in tender/order. The warrantee shall be against defective design, defective quality material supplied, manufacturing defects etc. for a minimum period of 12 months from the date of Installation & Commissioning of kit/Jig or 15 months from the date of supplies whichever is earlier.
- b. The Tenderer have right to offer warrantee more than 12 months from the date of Installation & Commissioning of kit/Jig or 15 months from the date of supplies whichever is earlier.
- **13.** General Manager, NSIC-Technical Services Centre reserves the right to reject the tender/bid wholly or partly without assigning any reason and to restrict the list of qualified Tenderer for opening of bid to any number deemed suitable by him from out of bids received.
- **14.** In the event of any dispute the legal matter shall be subjected to the jurisdiction of Delhi Court only.
