1. Tenderers shall submit their offers in a sealed cover super scribed as “**Tender for Used Machines**” at NTSC Chennai on or before **14.12.2011** up to **3 P.M.**
2. The machines as details mentioned in the Notice Inviting Tender are offered for sale on “**AS IS WHERE AND AS IS WHAT BASIS**” without any guarantee as to the condition of any items to be sold. The purchaser shall not be entitled to raise any objection on the ground that the general description of the machine does not tally with the items or any item does not tally with the items of which delivery is affected. The description of the machines is believed to be correct and sold with the assumption that the purchaser had inspected it and fully aware about the conditions of the machines. The purchaser is not entitled to raise any objection at a later date regarding the description, conditions, and quality etc. of the machines or for non – delivery of any items.
