The successful tenderer will have to lift the material/scrap at their own cost from the premises of this Center, after acceptance of his offered tender the full payment is to be make in favour of centre by DD. DD to be drawn on the name of **National Small Industries Corporation Ltd. payable at Rajkot.**
3. Quantity mentioned in the tender is purely approximate and tenderer if wishes may quote the rates after inspecting the material at site. No dispute regarding quantity will be entertained by this Center in any manner.
4. An E.M.D. in the form of a DD OR Cash receipts of Rs. **10000/-** will have to be enclosed along with Tender.
5. In case the Tenderer fails to lift the all the material/scrap awarded by C.A. after acceptance of his tender within stipulated time the amount of EMD will be forfeited and tenderer will have no claim what so ever over it. EMD of the unsuccessful tenderer will be refunded within 90 days after assigning the acceptance letter to the successful tenderers. Tender without EMD will be summarily rejected. EMD will not be adjusted against delivery of material.

Successful tenderer will lift all the material/scrap which is awarded by C.A. and after lifting the material will produce a computerized weigh Bridge Slip for measuring the quantity lifted in case unit's measurement is in Kg. and such measurement will have to be done in the presence of Officer In charge or his appointed nominees of NSIC TSC, Rajkot. Further where unit of measurement is in number, the same has to be done in presence of officer in charge or his appointed nominees of NSIC TSC Rajkot The actual measure / quantity delivered will be base of making payment of items lifted
7. Successful tenderer will be given an acceptance letter by this Center and then only he will allow lifting the material.
8. In case successful tenderer fails to lift the material/scrap within stipulated time of 15 days Storage charges @ 1% of the quoted value of the item per day will be levied.
