Technical Bid – Envelope- 1

Detailed description of the Placement records, NSIC Registration if any (preference will be given to NSIC registered institutes) ISO certification if any along with the Demand draft / Receipt for tender fee. Customer feedback from past sponsoring agency.

Commercial Bid - Envelope- 2

One sealed cover containing Forwarding letter, complete EOI document indicating the course fee per candidate.

CRITERIA FOR QUALIFYING TECHNICALLY

The following points shall be considered for qualifying the technical bids.

- 1. The centre must have 10 years experience in conducting placement programme.
- 2. Turnover must not be less than 40.00 Lakhs.
- 3. List of staff along with their qualifications.
- 4. The placement record should be satisfactory. Name of the companies where students are placed.
- 5. Placement centre having Public Private Partnership with NSIC will be given preference in this EOI.

Note: While assessing technical Competency weight age marks will be assigned for all the above parameters.



COMMERCIAL AND GENERAL TERMS & CONDITIONS

Price: - Price should be most competitive (EX- WORK PRICE).

Placement starting Period: Within 15 days from release of Work order if delayed 0.5% per week will be deducted from the basic placement fees.

Validity of the Offer: - The offer should remain valid for a period of 90 days.

Placement Support : Assistance must be given in order to place minimum 75 nos. of the Trainees belonging to SC/ST passed out from NSIC, Technical Services Centre Howrah.
