- 3. The responsibility of C & F agent starts from receiving the goods at ICD Tughlakabad up to handing over of the consignment to the buyer at Ouagadougou Dry Port. Only Shipping Line B.L with clear mention of delivery up to Ouagadougou dry port is acceptable.
- 4. The detailed routing along with tentative schedule, on the letter head of shipping line, shall be provided to the NSIC along with the BL.
- 5. All charges to be quoted shall be all inclusive, including Service Tax or any other tax, as applicable.
- 6. General Manager (Tech) has right to reject any or all of the offers received, at any stage of processing of offers received against this request, without assigning any reason.
- 7. The rates quoted above shall be valid for 120 days from the closing date of submission of offer i.e. rates shall be valid up to 31.01.2015.
