General Terms and Conditions:

- **1. Scope of work**: To provide vehicle for official use by Zonal / Branch Office of the Corporation at Mumbai on monthly hire charges basis. The maintenance and up-keep of the vehicle, fuel consumption, driver and its pay or other allowances including the statutory dues if any shall be to the account of contractor / travel agent providing the service. 2200 kms running per month is anticipated.
- 2. <u>Duration of Contract</u>: The contract shall be valid for one year which can be renewed by mutual consent between the contractor and the corporation.
- 3. <u>Duty Timing</u>: Shall be from 9 am to 6.30 pm usually i.e. 9.5 hours per day or 250 hours per month.
- 4. <u>Duty Days</u>: Six days per week. However, vehicle can been called on any holiday or close day. One weekly off shall be provided.
- 5. <u>Driver Uniform</u>: The driver provided with the vehicle shall be in uniform neatly cleaned and pressed. He will also have a visiting card from the service provider.
- 6. <u>Vehicle condition</u>: Vehicle shall be in excellent condition mechanically and the outward body and seating with appropriate lights / belts and other necessary accessories functional and in order. In case of the break down of the vehicle on duty the service provider shall provide alternate vehicle immediately.
- 7. **Fuel & Maintenance**: The vehicle shall be adequately maintained by service provider. The vehicle will report with adequate fuel minimum for the day's work and in case of outstation the service provider will have arrangement made with the driver / service stations for re-fueling of the vehicle or normal wear tear / defects which may occur during the visit. In case of outstation breakdown, the service provider will compensate the return by road of the visiting officers.
