Terms & Conditions

1. Materials of approved quality / make as specified in the schedule shall only be accepted.
2. The tender should be accompanied with the earnest money deposit of Rs.10, 000/- in the form of account payee demand draft in favour of "National Small Industries Co. Ltd", payable at New Delhi. No Cheques are acceptable. Tenders without EMD will be summarily rejected.
3. The tenderer shall take into account basic price, cost of labour, T & P, taxes as applicable, conveyance / cartage etc. before quoting the rates. No extra claim what so ever in this regard shall be entertained. Parties are required to quote there Pan No., Tin Non, Service Tax no. , ESI Code and PF Code.
4. The EMD deposited by the successful tenderer shall be converted into security deposit. The EMD of the rest of bidders will be refunded after award of the contract. Security deposit of Rs. 10, 000/- will be retained by the Corporation and the same will be refunded after successful completion of the warranty period of one year from date of completion of work.
5. The bidder shall ensure that all materials / equipment rendered shall confirm to the purchaser's requirement and specification. The bidder shall guarantee the materials / equipment offered for a period of 12 months from the date of supply. During this period, the party should be responsible for carryout the damaged/rusted or not working components which was covered under scope of work has to be replaced free of cost with new one.
6. Work should be completed within 30 days from the date of acceptance of work order. In case work is not completed within schedule time liquidated damage @ 2% per week shall be charged.
7. The tenderer may inspect the premises for getting acquainted before submitting the quotations during office hours on any working day. Non-familiarity with the site condition will not be considered a reason either for extra claims or for not carrying out the work.

8. The validity of quotation should be 60 days from the last date of submission of tenders.
9. While applying for the tender document, the intending tenderers shall furnish proof of experience certificates, works completed / awarded.
10. Any disputes relating to specification in quality of the spares and materials replaced under Servicing / repairing of Fire Fighting accessories or any other claim raised by other party will be referred to the arbitrator appointed by CMD, NSIC LTD. and the decision of the arbitrator will be final and binding on the both the parties.
11. NSIC reserves the right to reject all or any tender wholly or partly without assigning any reason whatsoever.
12. Payment shall be release after successful competition of work and Statutory taxes like income tax, work contract tax/service tax etc. as applicable shall be deducted from the payment.
13. The bidder must confirm their acceptance of the terms and conditions mentioned herein and the enclosed documents. Each page of the original tender document should be signed and returned back and this will form a part of contract.
14. Quantities mentioned in the schedule of quantity are tentative and may increase or decrease as per requirements.
