- 3. The AMC is for preventive as well as for breakdown maintenance of air conditioners installed in different offices of NSIC.
- 4. The AMC is comprehensive and include repair and replacement of parts like compressor, starting components, coil filter, thermostat, selector switch, escutcheon plate, contactor, Condenser coil, cooling coil, overload relay, canvas, fan/ blower motor and charging of gas free of cost.

- 6. The tenderer should have minimum three years experience of similar nature of works. He will have to submit the relevant documents as proof of his experience or else his tender will be rejected.
- 7. In case the complaint is not attended within 24 hrs. penalty @ Rs. 200/- per day shall be levied subject to a max ceiling of Rs 2,000/-.

- In case of defect involving replacement of the compressors, the work has to be completed within 48 hrs. failing which penalty @ Rs. 500/- per day shall levied subject to a max ceiling of Rs 5,000/-.
- 2. All window/Split AC's & ductable ACs are of reputed brands hence the genuine spares shall be allowed after certification by the Engineer-Incharge. The old parts shall be returned to the Corporation.
- 3. The validity of the quotation should be 90 days from the last date of the submission of tenders.
- 4. The following Shall not be a part of this contract:: Electronic remote control, Voltage Stabilizer, All plastic components,
 Heating element, Front Grill, Bottom Tray, Cabinet cover and sheet metal
 parts and shifting charges of window/split/ductable ACs.
- 5. Preventive maintenance service would be carried out by the service provider regularly to keep the equipment running in a trouble free condition during the period of contract. Wash the filter of all the ACs every month.
- 6. A record of preventive maintenance carried out would be maintained by you and duly certified by the authorized officer.
- 7. All the faults will be attended at site of Corporation. In case of a major fault, if the machine is required to be taken to the company workshop, the company shall provide a replacement unit till the time the AC sent for repairs is positioned back.
- 8. In cases of poor workmanship and non-compliance of tender/agreement or services provided by the contractor are not found to be satisfactory, the contract shall be terminated by the department by giving 10 days notice even before the expiry of contract period and shall be forfeited the security deposit without assigning any reason what so ever.
- 9. The company shall provide minimum 02 full services (i.e. washing etc.) of each AC during the duration of AMC Period one year.
- 10. On selection, the agency shall be required to deposit 10% of the total cost of work as Security deposit and the same will be refunded after successful completion of the period of AMC as specified in the work order.

- 11. The AMC shall be for one year and it will be affected from the date of award of work. However, the corporation reserves the right to enter into AMC for another year on the same terms and conditions provided the services rendered by the bidder are satisfactorily.
