2. The Tender should be accompanied with the Earnest Money Deposit equivalent to 5% of the total quoted price (by adding the price quoted for each machine) in the form of a Demand Draft/Pay Order in favour of “**NSIC Ltd.** payable at Rajkot. **No Cheque or cash shall be accepted. The offers without Earnest Money Deposit will be rejected.**
