#### **CRITERIA FOR QUALIFYING TECHNICALLY**

The following points shall be considered for qualifying the technical bids:

- 1. Specification of the Tenderers must match to our specified technical specification.
- 2. Tenderers should have sufficient infrastructure to justify their competence of supplying the system. If felt necessary their infrastructure facility/ spectrometer shall be inspected by a team of NSIC officers.
- 3. Tenderers must give the list of customers whom they have supplied similar sort of Machinery used for chemical testing along with their address, name of the contact person and tel. no, e-mail address, Fax etc. with satisfactory report from the customers.
- 4. If the Tenderers have supplied machinery to NSIC earlier, should provide those details.
- 5. ISO Certification would give an added weight age marks.
- 6. The aforesaid machine must have the provision for inclusion of Nitrogen Element in Steel and any other software for future expansion of testing facility.

**Note**: While assessing technical Competency weight age marks will be assigned for all the above parameters.

#### TECHNICAL, COMMERCIAL AND GENERAL TERMS & CONDITIONS

- 1. Price: Price should be most competitive including Transit Insurance, Freight, Packing and Training charges etc
- **2. Delivery and Installation Period**: Within 60 days from release of Supply order, if delayed 0.5% per week will be deducted from the basic price of the machine. The machine/spectrometer/accessories should be supplied duly calibrated by a NABL accredited lab.
- 3. Validity of the Offer: The offer should remain valid for a period of 60 days.
- **4.Guarantee Period:** The guarantee/warranty period should be minimum **one year** from the date of commissioning for any kind of defect, fault and malfunctioning.
- 5.Taxes and Duties: Taxes and duties if any shall be paid extra. No "C" & "D" Form will be issued by NSIC
- **6.Freight & Transit Insurance**: The machinery/ Spectrometer/Equipments to be delivered and insured against damage during transit from the manufacturer's workshop up to Howrah centre by the supplier. No extra charge shall be borne by the NSIC.
- **7.Packing**: The machinery/ Equipment shall be properly packed for safe arrival of the machine to Howrah centre and no extra charge will be borne by the NSIC.
- 8.Payment Terms:- In case the offer is accepted, payment would be released as under:
  - (A) 80% against the arrival of the item in the Howrah centre in good condition and submission of dispatch documents and tax invoice etc.
  - (B) 20% balance payment within 30 days after satisfactory installation and commissioning and training of our officials for three days at least.
- **9.Installation and Commissioning**: The awarded bidder shall have to depute expert(s) for installation & commissioning at Howrah centre. No train fare or any mode of travelling expenses and accommodation/outstation charges for the expert deputed by the supplier shall be paid by NSIC.
- 10. Supplier must have fully fledged service centre at Kolkata/Howrah to provide prompt services.
- 11. Each page of the bid should be signed by the authorized person. Letter regarding the authorization of such person should be obtained from the Principal/Manufacturer and enclosed with the bid.
- 12. Bid should not contain any terms & conditions, printed or otherwise, which are not applicable to the bid.
- 13. Any conditional bid not adhering to the terms & conditions of the tender, specification of the Spectrometer or part bid shall be rejected.
- 14. In the financial bid, prices are to be indicated in both figures & words. In case of any discrepancy of value the prices quoted in words shall be considered for evaluation & establishing L1 status.
- 15. No price variation clause will be entertained.
- 16. Manufacturers/Suppliers should submit their best price and they will not be allowed to revise the price. Any revision /discount given by manufacturers/ Suppliers subsequently will be ignored.
- 17. The bidders should be registered with Sales Tax/Income Tax department of Govt. of India and should hold a valid VAT Registration certificates, as applicable.
