- Tenderer shall submit their offers in sealed covers, super scribed as "Quotation for Supply and installation of Digital Franking Machine" *Enquiry No and Due Date,* addressed to the Chief Manager (Admin) should reach this office on or before 14.01.2011 up to 3.00 P.M. The offers will be opened on same day at 3.30 PM. Quotations received after due date will not be considered
- Materials of approved quality / make as specified in the schedule shall only be accepted. The tenderer along with their offer should submit earnest money of Rs. 5, 000/- in the form of Demand draft in favour of "NATIONAL SMALL INDUSTRIES Corporation" payable at New Delhi". No Cheque is acceptable. Tenders without EMD will be summarily rejected.
- 3. The dealer shall take into account basic price, cost of labour, T & P, taxes as applicable, conveyance / cartage etc. before quoting the rates. No extra claim what so ever in this regard shall be entertained.
- 4. The validity of quotation should be 30 days from the last date of submission of tender.

- 5. Earnest money of unsuccessful bidder (Other than the lowest bidder) shall be returned after opening of tender and earnest money of successful tenderer shall be retained as security deposit for one year as warranty period from the date of completion of above work.

- 10. Digital Franking Machine for dispatch of official letters and parcels (minimum 250-300 letters per day).
