2. Tenderers should set their quotations in firm figures. Each figure stated should be repeated in words also. In the event of any discrepancy between the amount stated in figures and words, the rate quoted in the words shall be deemed to be the final quotation. Tenders with qualifying term such, as “SUBJECT TO A MINIMUM ACCEPTANCE etc shall be liable to disqualification.
3. The bid will be opened first and suitability will be analyzed.
4. Tenderer must furnish illustrative literatures, catalogues and complete photos of details for the existing Exhibition.
5. Tenderer shall submit USER’S LIST of the Exhibition quoted along with the tender.
6. Last date of the receipt of this tender is 16/01/12 up to 2.00 PM. Tenders received after this due date will not be entertained. bids will be opened on the same day at 4.00 PM.
