#### **INSTRUCTIONS TO TENDERERS**

- 1. The Allied Services Agency shall have good credentials and not have been blacklisted by any Govt. firm for which a declaration is required from them on their letter head.
- Tenderers are advised to acquaint themselves fully with scope of services, time schedule and terms and conditions including all the provisions of the tender document before framing up their tender.
- 3. Tenderers are advised to inspect and examine the campus and its surroundings and satisfy themselves before submitting their tenders.

#### **TERMS & CONDITIONS**

- 1. The working hours for each person will be of 8 (eight) hours (viz. 9.30 A.M to 6:00 P.M, considering half hour lunch).
- Statutory obligations like payment of ESI, PF contribution, Income Tax, etc. and any other tax as applicable are to be paid by Allied service Agency for the manpower provided, directly to the concerned authority and the challans (attested photocopy) for the same are to be submitted to us for our record and further necessary action at our end.
- 3. Allied Services Agency shall have to submit the list of manpower personnel deployed along with the name, address, father's name, qualification etc. and two nos. of passport size photographs for our record. Police verification shall be Tenderer responsibility & doc.copy is to be submitted.
- 4. Unfurnished accommodation will be provided at this Centre for the personnel and as such no HRA will be paid by us.
- The electricity & water charges for accommodation provided are to be deducted from the wages of manpower deployed and to be paid to NSIC (these charges shall be revised & freezed generally on six monthly basis).
- 6. Alcoholic consumption, gambling and other unlawful activity inside the campus is strictly prohibited.
- 7. Period of contract shall be 2years extendable once for 2years on performance of Tenderer. It may be reduced or the contract may be terminated, if satisfactory service is not provided by giving 30 days advance notice.
- 8. The agency may also terminate the contract by giving 30 days advance notice to NSIC-Technical Services Centre, Howrah.

- 9. We will not be responsible for any compensation or any loss, injury, whatsoever in nature which may occur to the security guard/gunman on hire.
- 10. Your bill will be paid by A/c payee cheque only by the 10<sup>th</sup> of every month after submission of your bill at the beginning of the next month in respect of the previous month with all documents as required. You are required to abide by State applicable regulatory laws for salary disbursement.
- 11. Any loss, theft and damage due to negligence or by any other means committed by any of your manpower should be replenished by you.
- 12. The manpower should be placed under the disposal of the Centre during the period of their service and they should obey the orders of the controlling officer of the Centre and Head of the Organization.
- 13. The manpower should be physically fit and mentally alert.
