**Ques: -** Who can apply for NSIC – Training Cum Incubation under Public Private Partnership (PPP Mode)?

**Ans.** The organization associated with Educational and Technical Institution, Company, Firm & NGO are eligible to apply.

**Ques: -** What is documents required for applying NSIC - Training Cum Incubation under Public Private Partnership (PPP Mode)?

**Ans.** The documents checklist required of is available on NSIC website with application form.

**Ques:** - What is the minimum area required to established the NSIC – Training Cum Incubation under Public Private Partnership (PPP Mode)?

**Ans.** The required area are depends on the course offered by the organization. However, the minimum area required is 2000 sq.ft.

Ques: - From where I can download the list of Courses?

Ques: - How much royalty will be charge by NSIC?

**Ans.** 15% of course fee of each trainee is taken by NSIC as a royalty, on behalf of royalty. NSIC issued the certificates of trainees.

**Ques: -** How much time it will take for getting the approval?

**Ans. First**, Unit has to summit the application form at our office.

**Second,** Application is thoroughly checked by NSIC officers and at the time of scrutiny of documents, if any documents are found not submitted, it shall be asked from unit

**Third** On receiving all the required documents, two inspection were carried out by NSIC officials i.e. **Preliminary inspection and Final inspection.** 

**Fourth** On recommendation of inspecting officer in Preliminary inspection, in principle approval is issued to unit.

**Fifth** after getting confirmation from the unit regarding readiness of centre in respect of installation of Machinery & Tools, selection of faculty etc. unit is finally visited by NSIC Officials.

**Sixth** On receipt of satisfactory Final inspection report, File is processed for approval before Competent Authority of NSIC.

**Seventh** after getting approval, unit is invited to sign agreement & Indemnity bond, which is applicable for one year.

**Eighth** After signing the agreement and Indemnity Bond, Final approval letter is submitted to Franchisee.

If organization will submit all the required formality with in the time period, then the whole process will take 40-45 days.

**Ques: -** How to apply for NSIC – Training Cum Incubation centre under Public Private Partnership (PPP Mode)?

**Ans.** Unit may apply on prescribed **APPLICATION** format with stated enclosures along with non-refundable application fee of (Rs. 5,000/-+18 % GST) by way of demand draft in favour of 'National Small Industries Corporation Limited.' payable at New Delhi. The application should be addressed to General Manager (Technology), The National Small Industries Corporation Limited, NSIC Bhawan, Okhla Industrial Estate, New Delhi-110020, India.
