

I have carefully examined the copy of RTI request dt. 06.02.2019, order of CPIO dt. 03.2019 and your appeal dt. 16.07.2019. It is observed that your RTI request dt. 06.02.2019 was disposed of by Sh. Manoj Lal, CPIO vide order dt. 05.03.2019, whereas you have preferred the present appeal on 16.07.2019 that is after a lapse of more than four months of

the CPIO's decision without showing any reasonable ground for such a long delay. It may be noted that Central Information Commission has held in the case of Mr. D. Prakasa Rao Vs. State Bank of India {CIC/VS/A/2012/000238/03083} that in the absence of any supportive documents to show any sufficient cause preventing the appellant from filing the appeal in time, it will be appropriate to consider that the appeal was time barred.

Considering the above, your appeal dt. 16.07.2019 stands rejected being time barred.
