ADDITIONAL TERMS & CONDITIONS (ATC)

1. Bidder office location: A registered office of the bidder must be located at Rajkot, Gujarat of Consignee. Documentary evidence to be submitted.

2. Earnest Money Deposit (EMD): Bidders has to submit the EMD through NEFT/RTGS in favour of NSIC Ltd. payable at Rajkot. Bidder has to upload scanned copy/proof of payment with bid. Details of Bank is as under:

However, MSEs Unit (bidder) having valid Udyam registration (classification year 2025-26) or NSIC registration, are exempted from paying EMD, provided they upload the relevant registration proof with the bid. EMD of unsuccessful bidders will be refunded after one month from the date of award of order to successful bidder.

3. Bidder financial standing. The bidder should not be under liquidation, liquidation, court receivership or similar proceedings, should not be bankrupt, not blacklisted with any organization. Bidder to upload undertaking on his company letter head with bid.

4. Bidder has to submit minimum 03 nos. of satisfactory completion letter from any Central/ State Government/ Govt. undertakings /PSUs in India during last 3 financial years where contract executed to be provided along with bid.

5. Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents sought in the Bid document, ATC and Corrigendum if any.

6. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actual or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

7. Dedicated toll Free Telephone No. for Service Support: BIDDER must have Dedicated/toll Free Telephone No. for Service Support.

8. Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).

9. Escalation Matrix for Service Support: Bidder must provide Escalation Matrix of Telephone Numbers for Service Support.

10. For fulfilling the experience criteria, any one of the following documents may be considered as valid proof for meeting the experience criteria:

(I) Purchase Order copy (any Central/ State Government/ Govt. undertakings /PSUs in India) along with Invoice(s) with self-certification by the bidder that supplies against the invoices have been executed.

(II) Execution/completion certificate by client with order value.

(III) Any other document in support of order execution like Third Party Inspection release note, etc.

11. ISO 9001: The bidder must have ISO 9001 certification.

12. NET WORTH Net Worth of the bidder should be positive as per the last audited financial statement Net worth statement of the company to be attested by banker.

13. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 30% of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 30% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

14. PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries/ wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer along with all statutory documents like. PF, ESIC etc. as well as the bank statement of payment done to staff.

15. The Successful Bidder has to make timely compliance of all payments/taxes on monthly basis such as PF, ESIC, GST etc., fails to which the same amount shall be withheld by buyer from monthly bill till the compliance is fulfilled.

16. Security deposit of 5% of the bid value to be submitted by the successful bidder (NEFT/RTGS). The said amount will not be given any interest on successful completion of the contract the same will be returned back. In case the bidder fails to complete the contract or is terminated the security amount will be forfeited. Details of Bank is as per sr.no.2 above.

17. The Successful Bidder has to provide ID Card, Safety Shoes (1 pair every year). Uniform (2 pairs every year), appointment letter, experience certificate etc. to all the contractual manpower.

18. The Successful Bidder has provide suitable manpower as requested by buyer at the earliest. It is responsibility of successful bidder to publish advertisement in different platform such as newspaper, recruitment portal, social media etc. to fulfil open vacant posting of suitable manpower at buyer location.

19. The Successful Bidder has to make compliance of all the applicable laws under Ministry of Labour & Employment.

20. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

(I). The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

(II). The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

(III). The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

21. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
