Bidders may submit their tender in consonance with the following terms & conditions:

1. The successful Tenderers shall pay lump sum total amount mentioned in the award order NSIC through online or by way of Demand Draft/Pay Order in favor of "The National Small Industries Corporation Ltd." payable at "Patna" towards the cost of Scrap, within two working days from the date of receiving the order.

3. Successful Tenders (H1) shall be responsible to remove the scrap within 3 days after payment of total amount in rupees in NSIC account.
4. The successful Tenderers shall arrange labour, tools & equipment for lifting and loading the scrap items and vehicle for transporting the items.
5. All responsibility related to labour P.F., ESI, Insurance etc. or any taxes as applicable will be of the successful Tenderers. NSIC shall not be responsible for the same.
