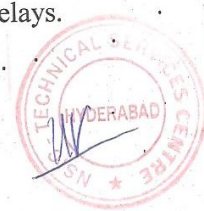

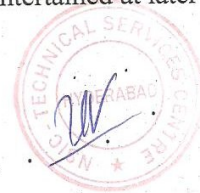
13. The Price quoted should be clearly mentioned both in figures and words. Any correction in rates shall be attested by the person signing the tender.

PAYMENT

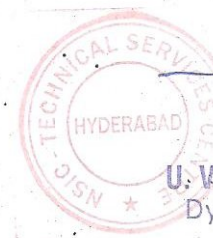
24. Payment shall be made after execution of the order to the entire satisfaction of the Corporation.
